## MSCI TO CONSULT ON CURRENT TREATMENT OF SPIN-OFFS WHERE THE SPUN-OFF SECURITY DOES NOT TRADE ON THE EX-DATE

**Geneva – October 26, 2005 -** MSCI Barra, a leading provider of benchmark indices and risk management analytics products, will consult on MSCI's current treatment of spin-offs where the spun-off security does not trade on the ex-date.

The objective of the consultation is to understand the views of market participants with respect to the treatment of spin-offs where the spun-off security does not trade on the ex-date, particularly when an indicative price is available for the detached security.

MSCI plans to contact directly some market participants to solicit feedback on our proposal. Please note that this consultation is intended solely to obtain information from market participants and may or may not lead to any changes in MSCI's current index methodologies. If MSCI determines to make any change, MSCI will make a public announcement in advance of the change.
