For the month of October, the MSCI Hedge Fund Composite IndexSM, an equal weighted index, gained 1.51%. The MSCI World Equity IndexSM gained 3.67% and the MSCI World Sovereign Debt IndexSM gained 0.92%. The MSCI Hedge Fund Database has grown to over 2,900 hedge funds and more than 190 indices representing over \$300 billion in assets. More than 95% of the funds in the database reported performance as of this index calculation.

Among the process groups, the MSCI Security Selection IndexSM performed the best by gaining 2.09%, followed by the MSCI Specialist Credit IndexSM which gained 1.41%. The MSCI Relative Value IndexSM posted the lowest return gaining 0.65%.

For October under the MSCI Directional Trading IndexSM, Discretionary Trading funds gained 1.65% and Systematic Trading funds gained 0.99%. Within the MSCI Relative Value IndexSM Merger Arbitrage funds posted the highest return for the month by gaining 1.06% while Arbitrage funds posted the lowest return for the month gaining 0.53%.

Under the MSCI Security Selection IndexSM, Long Bias funds posted the highest return for the month by gaining 2.55%. Short Bias funds posted the lowest return for the month declining by 4.22%. Within the MSCI Specialist Credit IndexSM, Long-Short Credit funds underperformed Distressed Securities funds with returns of 1.04% and 1.96% respectively.

Among geographic areas (Developed Markets, Emerging Markets & Global Markets), the MSCI Hedge Fund Emerging Markets IndexSM posted the highest return for the month gaining 2.43%, while the MSCI Hedge Fund Developed Markets IndexSM posted the lowest return gaining 1.36%. Note: MSCI Hedge Fund indices are hedged to remove the effect of currency on fund performance.

In terms of hedge fund size, the MSCI Security Selection Small Funds Index^{SM 1} posted the highest return for the month by gaining 2.12% with 3 year Sharpe Ratio of 1.24, while the MSCI Relative Value Small Funds Index^{SM 2} posted the lowest return of the month increasing by 0.55% with 3 year Sharpe Ratio of 0.9.

In terms of risk-adjusted returns, the MSCI Hedge Fund Specialist Credit, Core Funds IndexSM had the highest 3 year Sharpe Ratio of 3.55 with a return of 1.62% for the month, while the MSCI Hedge Fund Short Bias IndexSM had the lowest 3 year Sharpe Ratio of -0.52 with a return of -4.22% for the month.

Below is a brief description of the MSCI Hedge Fund Process Groups:

The **MSCI Directional Trading IndexSM** - MSCI defines Directional Trading strategies as those based upon speculating on the direction of market prices of currencies, commodities, equities, and bonds in the futures and cash markets.

The **MSCI Relative Value IndexSM** - Relative Value strategies focus on spread relationships between pricing components of financial assets or commodities.

The **MSCI Security Selection IndexSM** - Security Selection managers combine long positions and short sales with the aim of benefiting from their ability in selecting investments while offsetting systematic market risks.

The **MSCI Specialist Credit IndexSM** - Specialist Credit funds seek to lend to credit-sensitive issuers.

The **MSCI Multi-Process Group IndexSM** - Multi-Process Group comprises funds that practice a strategy whereby a single investment process does not account for more than 80% of their risk capital.

¹Small Fund Composite Index comprises funds with assets greater than \$15mm, but less than \$100mm.

²Core Fund Composite Index comprises funds with assets greater than \$100mm.
