Indices

MSCI中国指数系列由一系列国家指数、综合指数、境内以及境外指数组成，主要针对中国市场上的国际和国内投资者，包括QDII*和QFII*牌照持有机构。系列中所有指数基于MSCI全球可投资市场指数 (GIMI) 编制方法编制。

核心特征和优势

全面覆盖市场: MSCI 中国指数系列通过不同的组合，覆盖了中国市场的所有股票类型，如下表显示。并为国际投资者提供了针对中国股票市场全面多样的投资机会。

多样化的选择: 中国指数系列包括超过240只指数，体现各种投资中国的途径，包括旗舰指数 MSCI 中国A股指数，MSCI 环球中国指数，MSCI 中国海外股指数，MSCI 国际中国指数和MSCI金龙指数。所有指数按市值可分为大，中，小盘。

严谨的指数构建: 和所有MSCI全球股票指数一样，MSCI 中国指数系列经过严谨的方法构建，包括广泛的行业分布，自由流通调整，最小自由流通比例，流动性和市值筛选，年度及季度指数审核等。

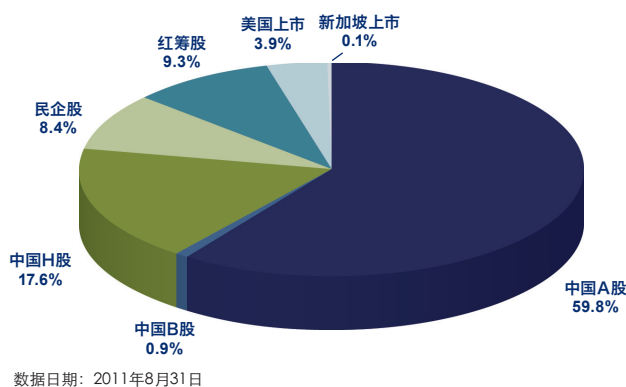

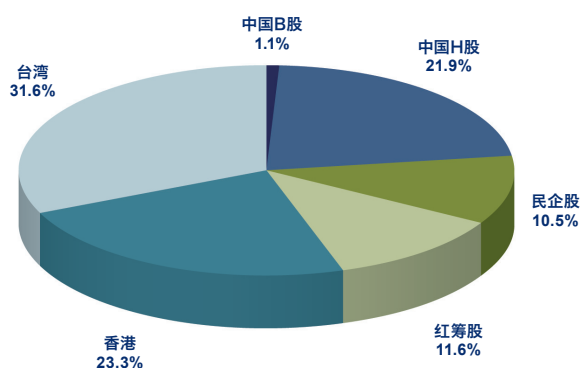
