# MSCI Canada 100% Hedged to CHF Index (CHF)

The **MSCI Canada 100% Hedged to CHF Index** represents a close estimation of the performance that can be achieved by hedging the currency exposure of its parent index, the MSCI Canada Index, to the CHF, the "home" currency for the hedged index. The index is 100% hedged to the CHF by selling the CAD forward at the one-month Forward rate. The parent index is composed of large and mid cap stocks.
