

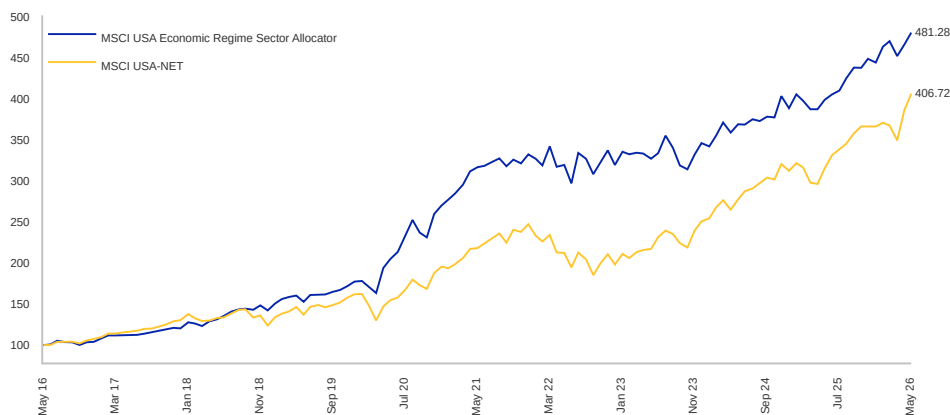
MSCI USA Economic Regime Sector Allocator Index (USD)
