The MSCI USA Small Cap Select Filtered Min TE Index aims to represent the performance of a strategy that is designed to improve the weighted average emissions intensity by at least 20% over the corresponding Parent Indexes while maintaining a weighted average ESG Score better than the weighted average ESG Score of the MSCI USA Small cap Index excluding the bottom 10% companies with the lowest ESG Scores.

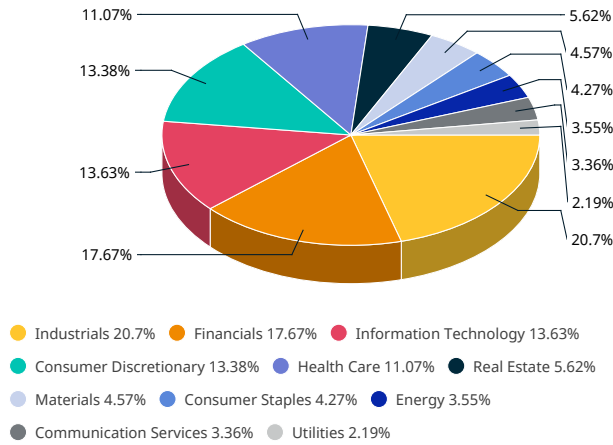
