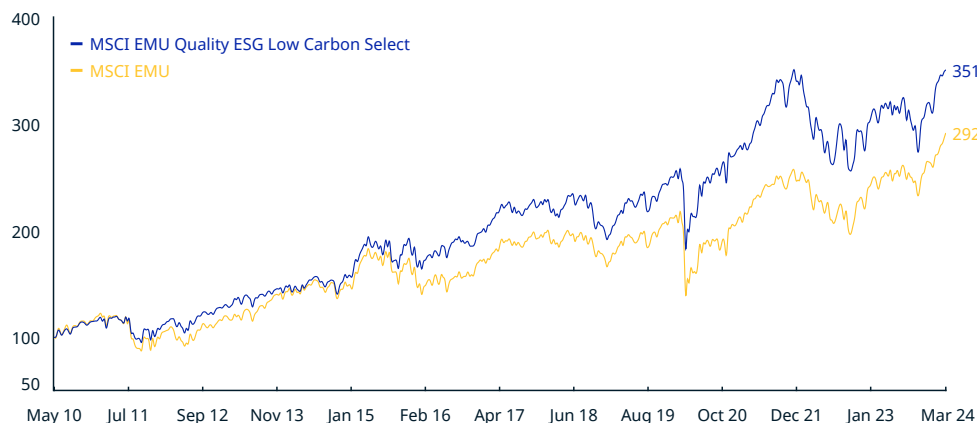


# MSCI EMU Quality ESG Low Carbon Select Index (EUR)

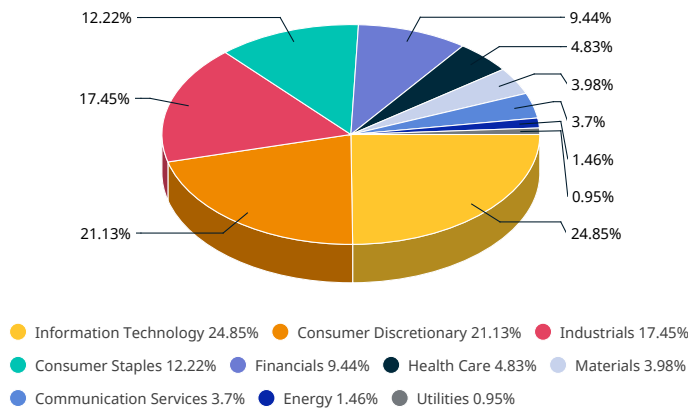
