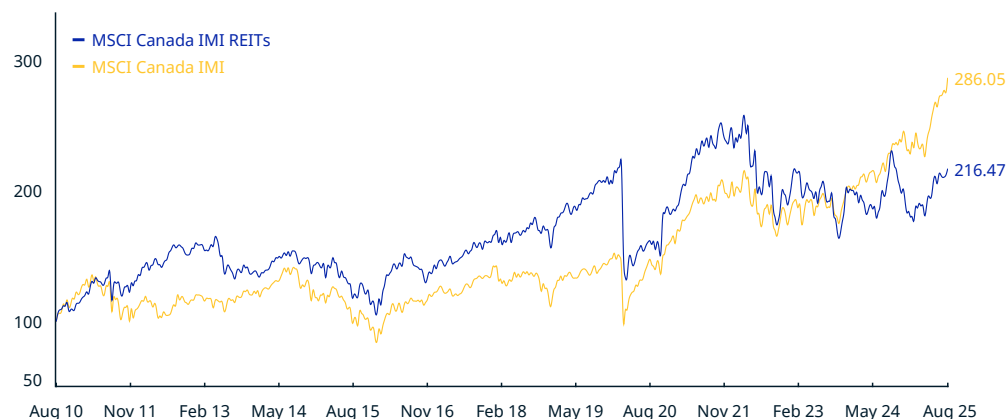


MSCI Canada IMI REITs Index (USD)

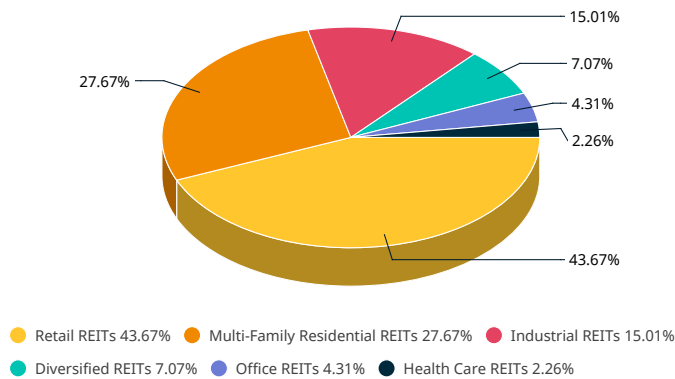
