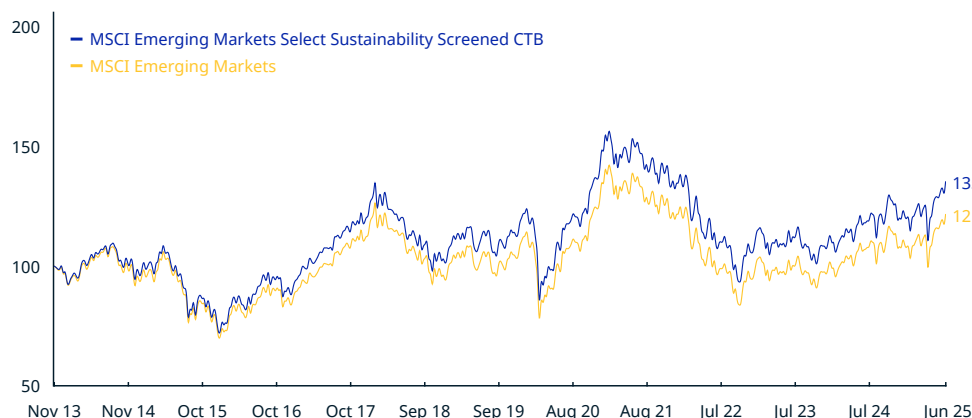


MSCI Emerging Markets Select Sustainability Screened CTB Index (USD)

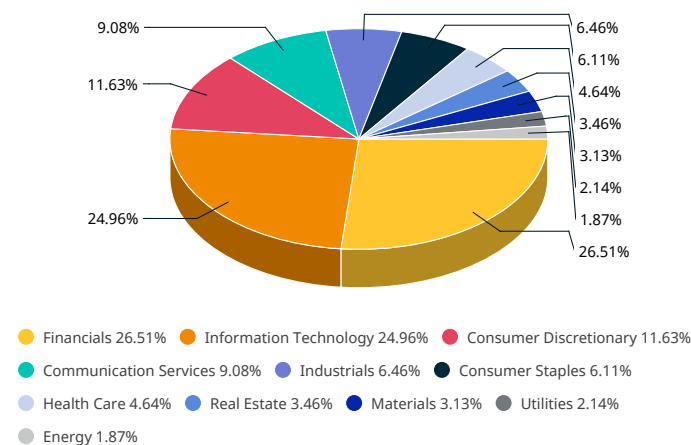

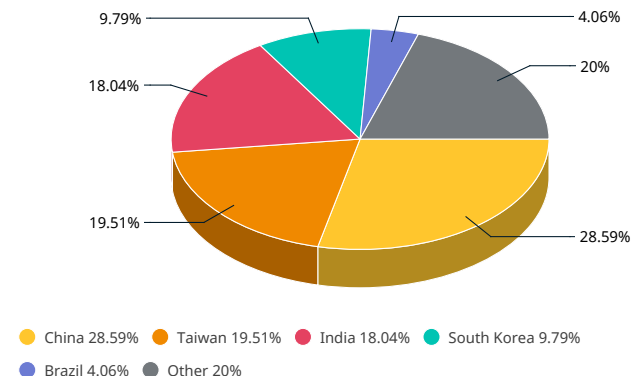
