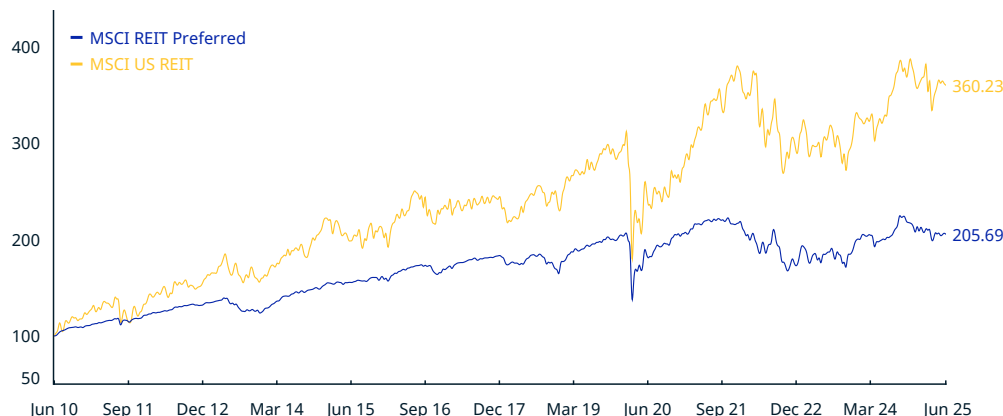


MSCI REIT Preferred Index (USD)
