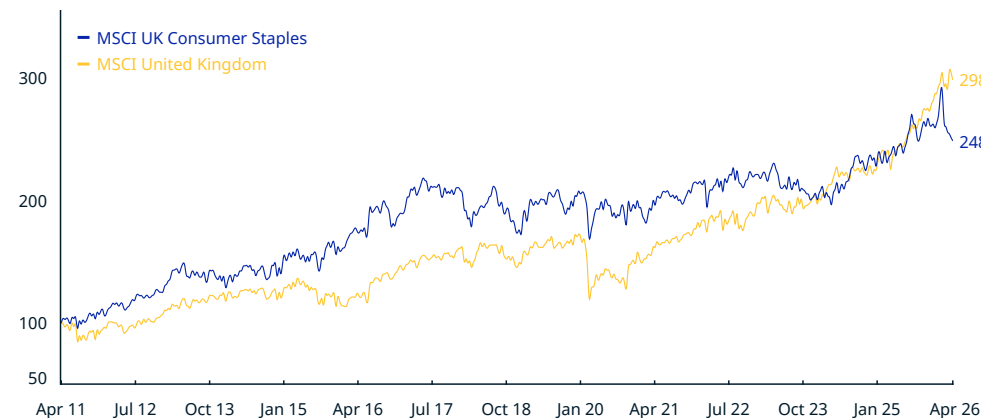


# MSCI UK Consumer Staples Index (GBP)

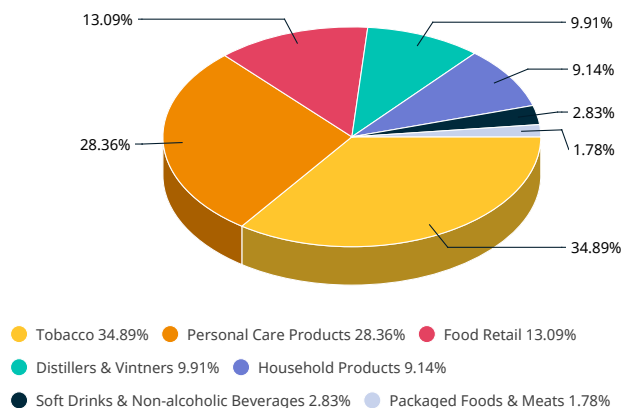
