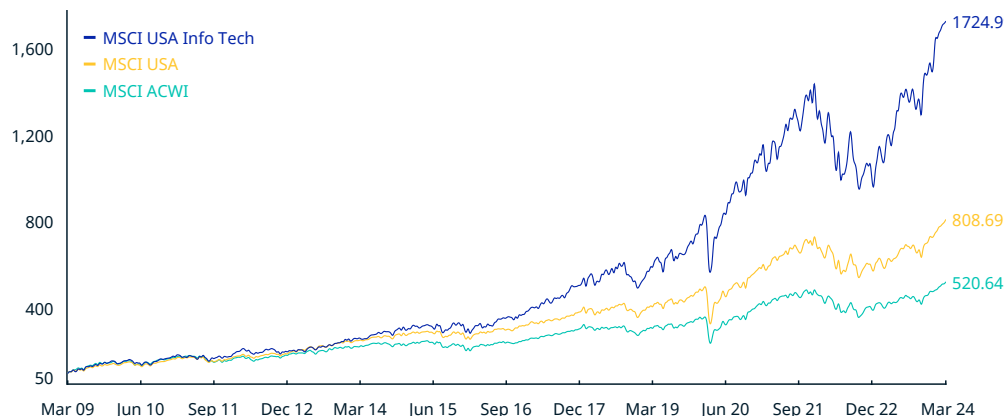


MSCI USA Information Technology Index (USD)

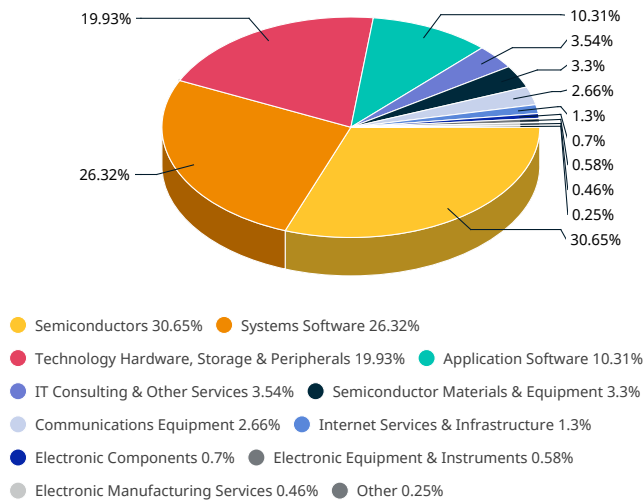
