

MSCI Japan Select ESG Rating Trend Leaders 100% Hedged to USD Index (USD)

The MSCI Japan Select ESG Rating Trend Leaders 100% hedged to USD Index represents a close estimation of the performance that can be achieved by hedging the currency exposures of its parent index, the MSCI Japan Select ESG Rating Trend Leaders Index, to the USD, the "home" currency for the hedged index. The index is 100% hedged to the USD by selling each foreign currency forward at the one-month Forward rate. The parent index captures large and mid-cap stocks of the Japanese equity markets. The index is designed to represent the performance of companies that have a robust ESG profile as well as a positive trend in improving that profile. The Index aims to target sector weights that reflect the relative sector weights of the underlying index to limit the systematic risk introduced by the ESG selection process. Overall the Index targets coverage of 50% of the underlying MSCI Japan Index.
