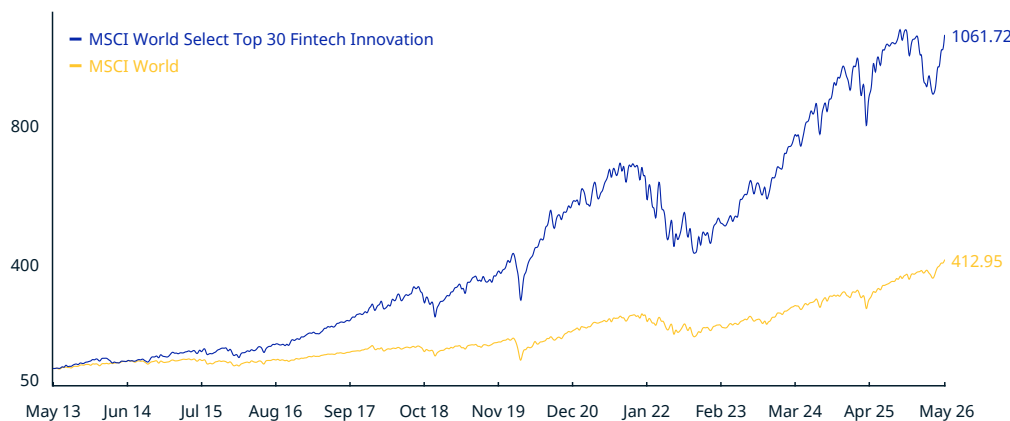


# MSCI World Select Top 30 Fintech Innovation Index (USD)

The MSCI World Select Top 30 Fintech Innovation Index is based on the MSCI World Index, its parent index, and includes large and mid-cap securities across 23 Developed Markets (DM) countries\*. The index aims to represent the performance of the 30 largest companies that are expected to derive significant revenues from the development of new products and services as a result of technological innovation in the financial sector. The index is further diversified by capping securities to a maximum weight of 10% at each index review.

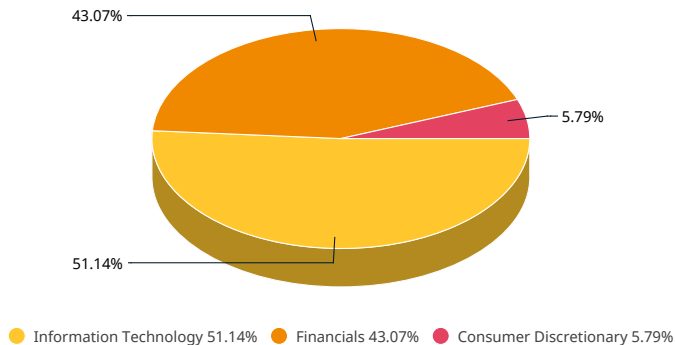

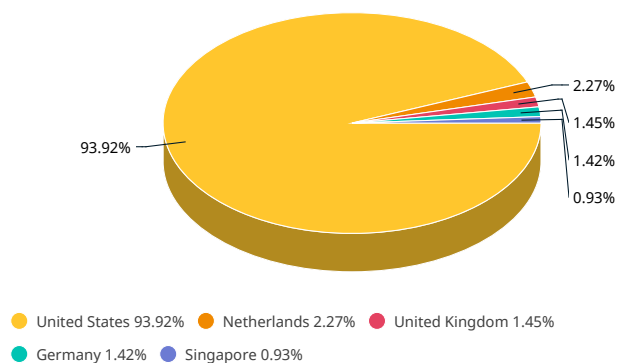
