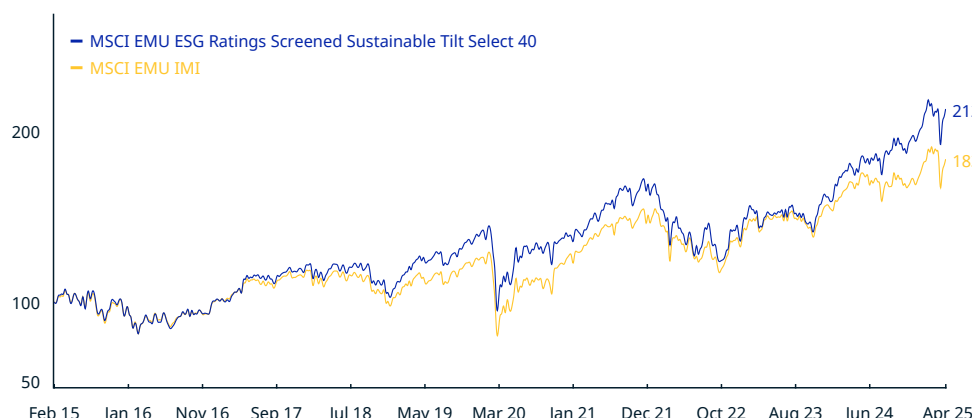


MSCI EMU ESG Ratings Screened Sustainable Tilt Select 40 Index (EUR)

The MSCI EMU ESG Ratings Screened Sustainable Tilt Select 40 Index (the 'Index') is based on its parent index, MSCI EMU index, which captures large and mid-cap securities across 10 Developed Markets countries in the EMU*. The Index aims to represent the performance of a set of 40 companies from the European Economic and Monetary Union region with highest free-float adjusted market capitalization and with a high exposure to sustainable investment.

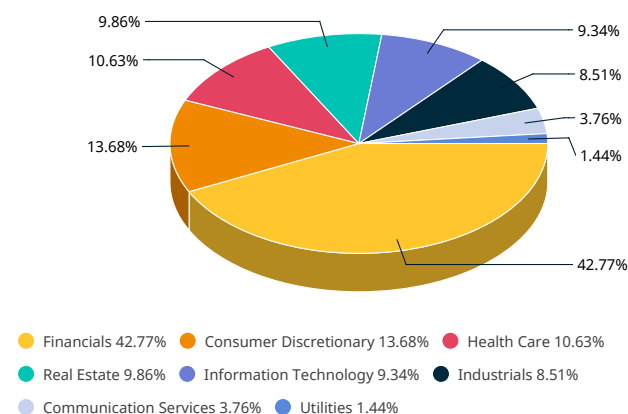

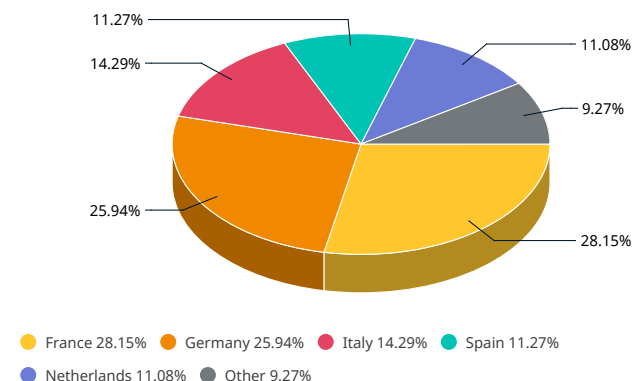
