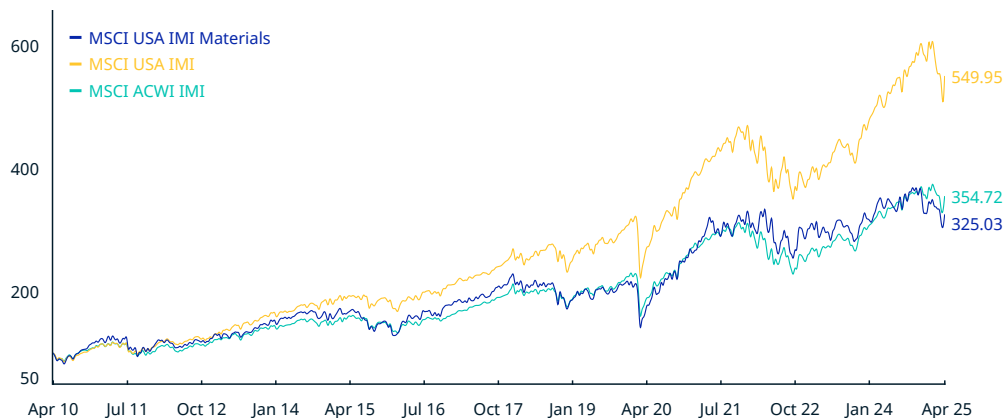


MSCI USA IMI Materials (USD)

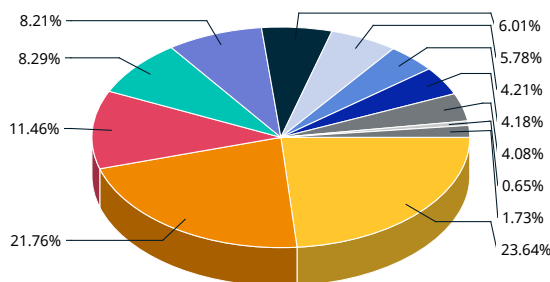
