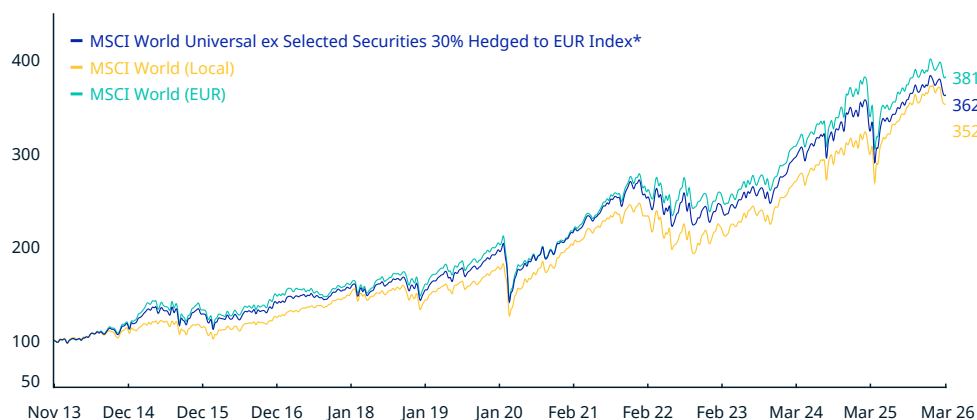


MSCI World Universal ex Selected Securities 30% Hedged to EUR Index* (EUR)

The MSCI World Universal ex Selected Securities 30% Hedged to EUR Index* *An MSCI custom index based on the stock exclusions provided by Mercer Global Investments Europe represents a close estimation of the performance that can be achieved by hedging the currency exposures of its parent index, the MSCI World Index, to the EUR, the "home" currency for the hedged index. The index is 30% hedged to the EUR by selling each foreign currency forward at the one-month Forward rate. The parent index is composed of large and mid-cap stocks across 23 Developed Markets (DM)[#] countries. The index is designed to reflect the performance of an investment strategy that, by re-weighting free-float market cap weights, seeks to gain exposure to those companies demonstrating both a robust ESG profile as well as a positive trend in improving that profile, using minimal exclusions from the MSCI World Index.

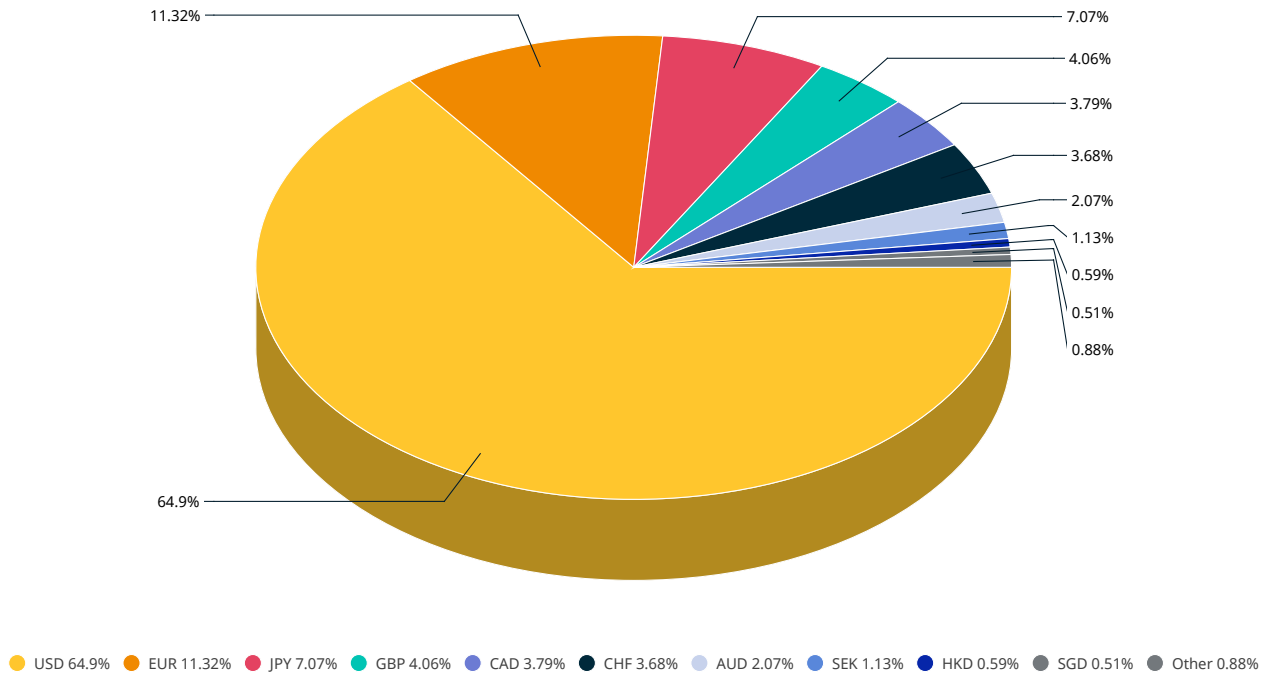
