In addition, securities are selected based on their 12-month Annualized Traded Value.

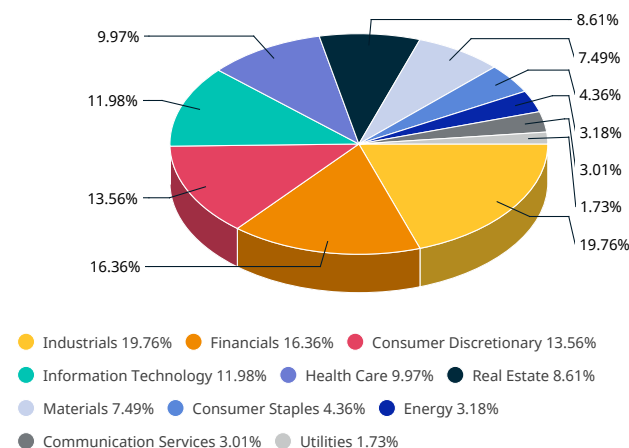

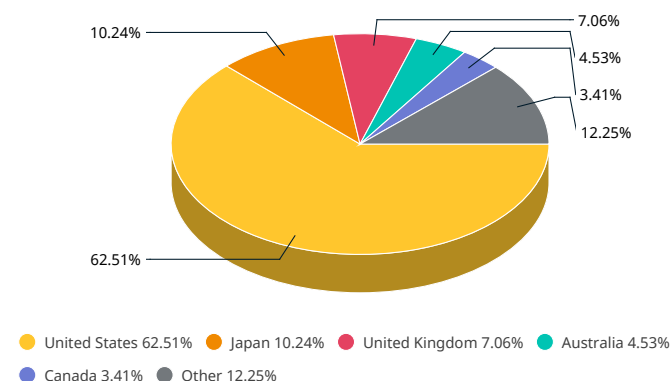
