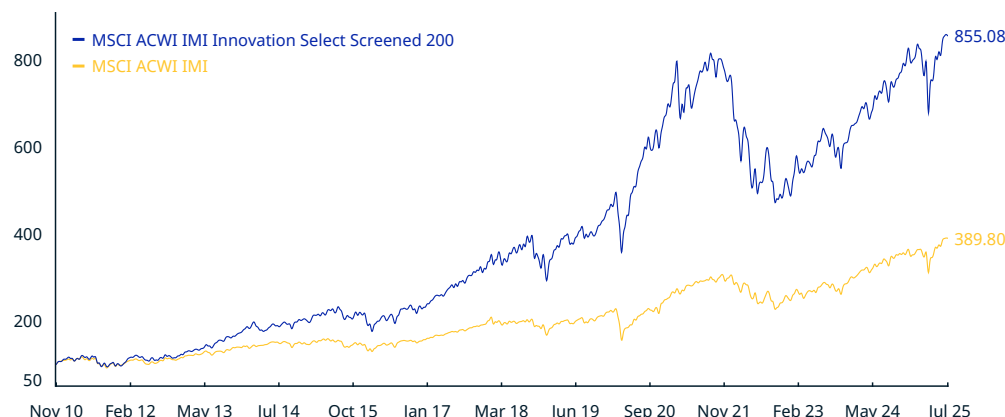


# MSCI ACWI IMI Innovation Select Screened 200 Index (USD)

The MSCI ACWI IMI Innovation Select Screened 200 Index is based on the MSCI ACWI IMI Index, its parent index, and includes large, mid and small-cap securities across 23 Developed Markets (DM) and 20 Emerging Markets (EM) countries\*. The Index aims to represent the performance of a set of companies that have high exposure to the following themes through a well-diversified, rules-based and transparent index - Autonomous Technology, Industrial Innovation, Genomic Innovation, Fintech Innovation, and Next Generation Internet Innovation while excluding those involved in certain controversial businesses or with relatively low ESG Ratings.

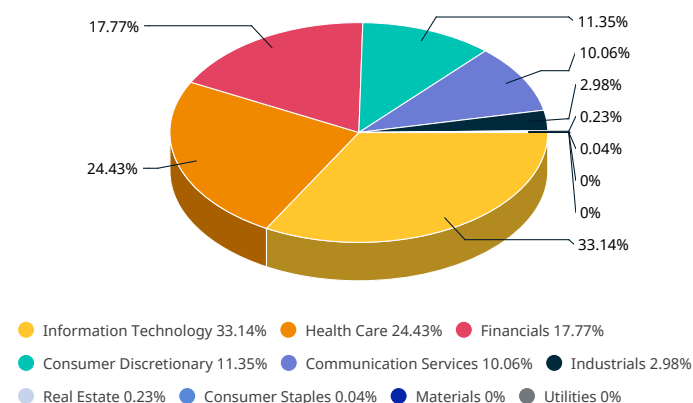

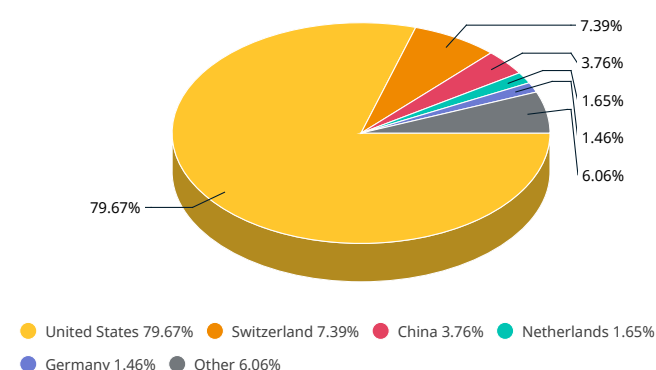
