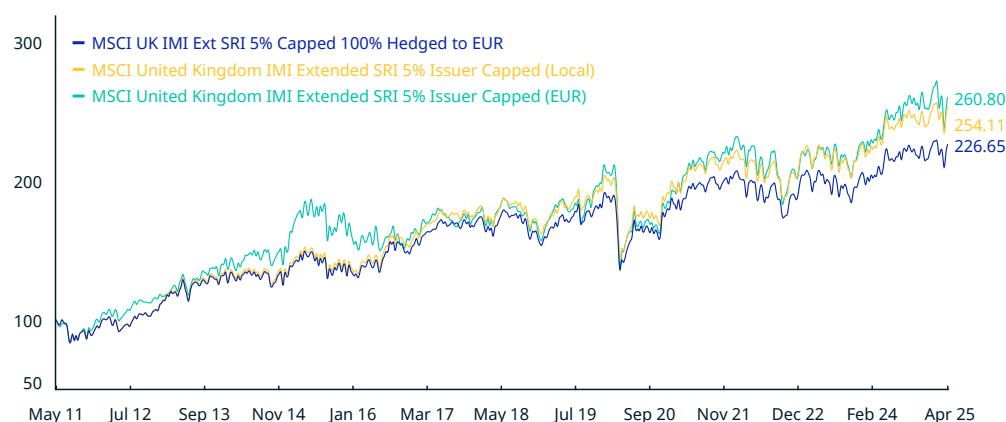


MSCI UK IMI Extended SRI 5% Capped 100% Hedged to EUR Index (EUR)

The MSCI UK IMI Extended SRI 5% Capped 100% Hedged to EUR Index represents a close estimation of the performance that can be achieved by hedging the currency exposure of its parent index, the MSCI UK IMI Extended SRI Index, to the EUR, the "home" currency for the hedged index. The index is 100% hedged to the EUR by selling the GBP forward at the one-month Forward rate. The Index is a benchmark for investors seeking exposure to UK companies with strong sustainability profiles while avoiding products whose social or environmental impact is considered to be negative by values investors. The index is a capped version that limits company concentration by constraining the maximum weight of a company to 5%.
