

MSCI Switzerland Sustainable Select 20 4% Decrement Index (CHF)

The MSCI Switzerland Sustainable Select 20 4% Decrement Index is based on the MSCI Switzerland IMI Index, its parent index, and includes large, mid and small-cap securities of the Swiss equity markets. The index aims to represent the performance of a set of 20 stocks from Switzerland that have a large free float adjusted market capitalization and a robust ESG profile. The index aims to avoid concentration by capping the weight of securities within the index to a maximum of 20% while applying a constant markdown ('synthetic dividend') of 4% on the net total return variant on an annual basis, expressed as a percentage of performance.



The Index applies a constant markdown ('synthetic dividend') of 4% on the net total return variant on an annual basis, expressed as a percentage of performance.

The index is reviewed on a quarterly basis coinciding with the May and November Semi-Annual Index Reviews and the February and August Quarterly Index Reviews of the Parent Index.
