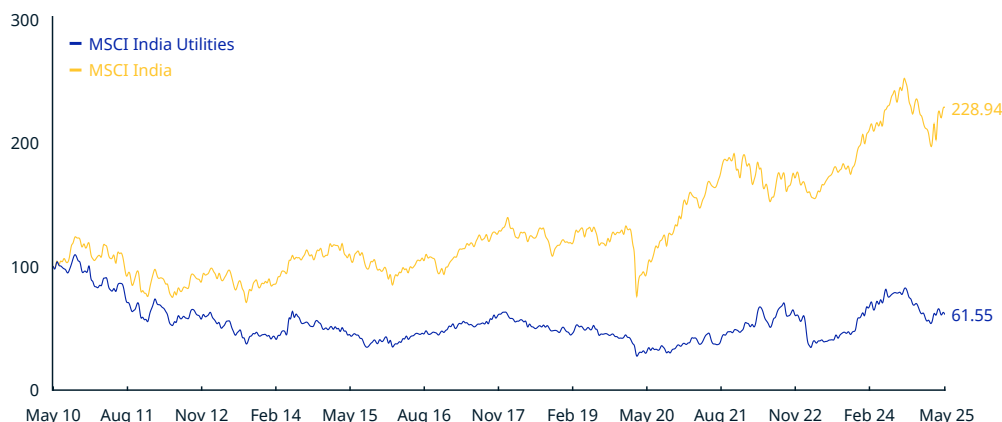


# MSCI India Utilities Index (USD)

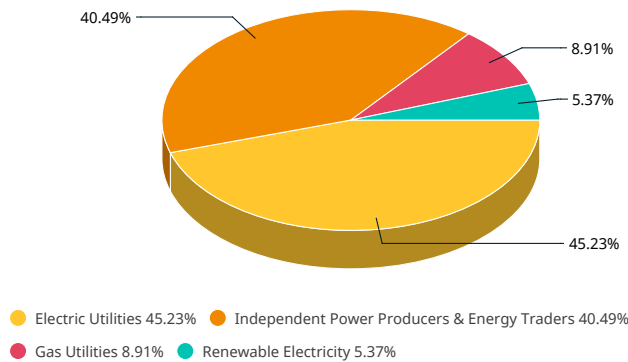
