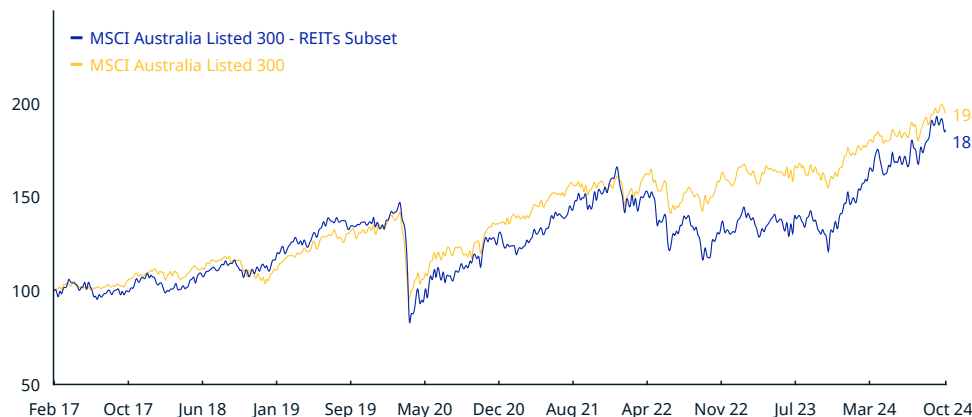


MSCI Australia Listed 300 - REITs Subset Index (AUD)

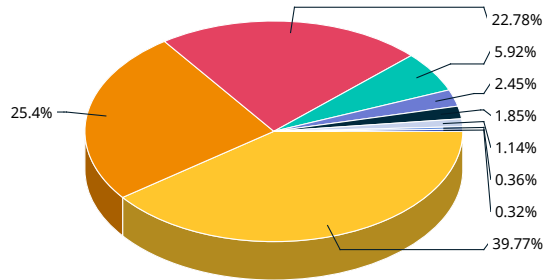
