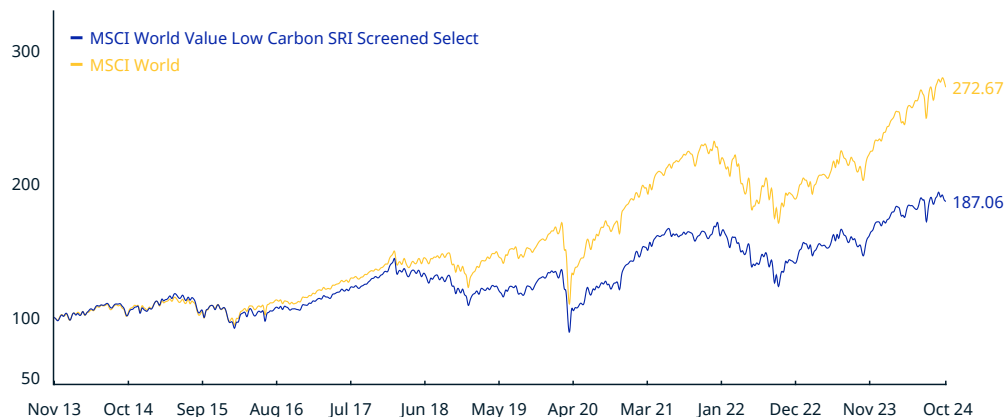


# MSCI World Value Low Carbon SRI Screened Select Index (USD)

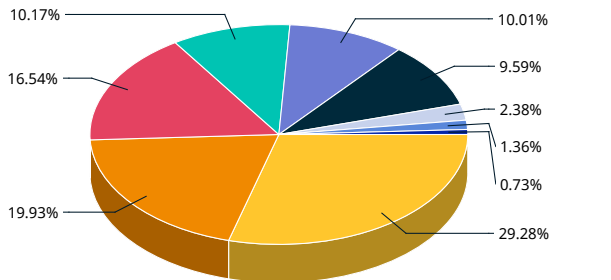

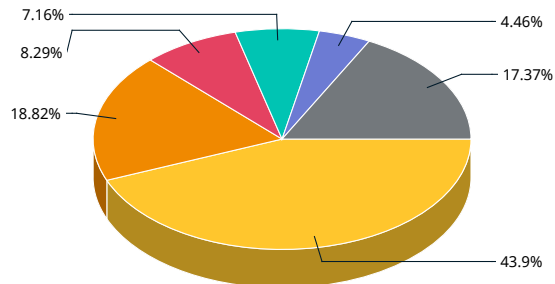
