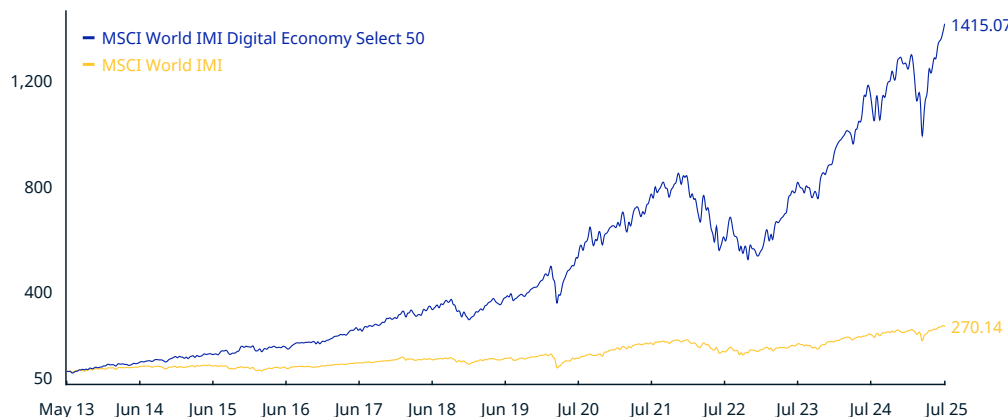


# MSCI World IMI Digital Economy Select 50 Index (USD)

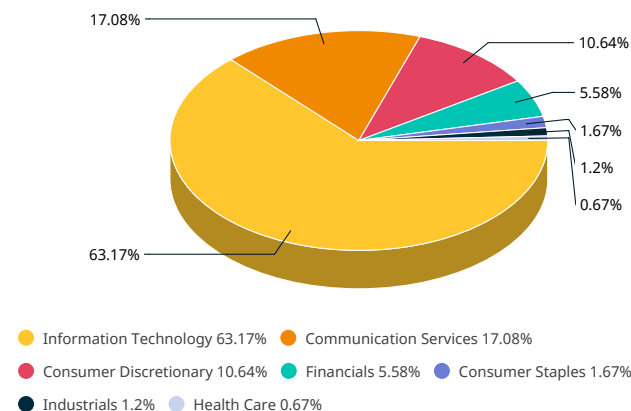

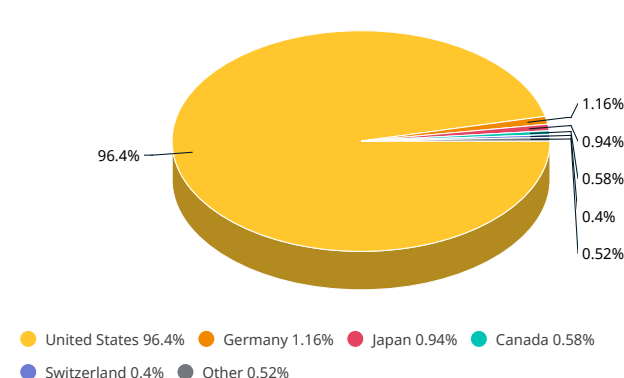
