

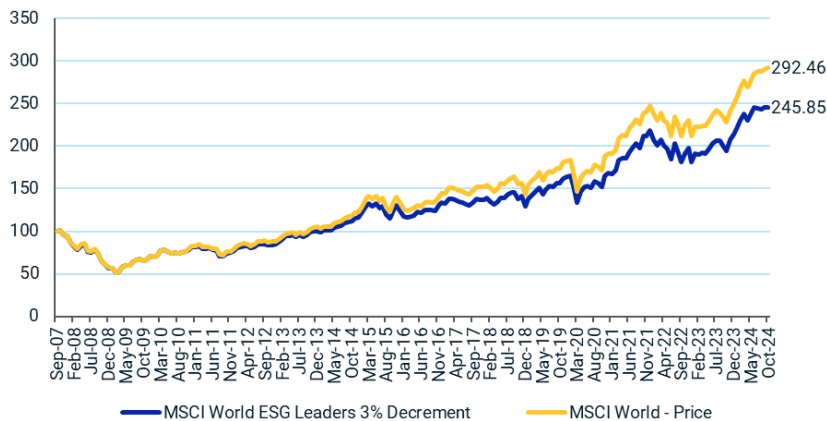
MSCI World ESG Leaders 3% Decrement Index (EUR)

The MSCI World ESG Leaders 3% Decrement Index is based on MSCI World ESG Leaders Index, its parent index and provides exposure to companies with high Environmental, Social and Governance (ESG) performance relative to their sector peers. The MSCI World ESG Leaders Index consists of large and mid-cap companies in 23 developed markets countries*. The Index is designed for investors seeking a broad, diversified sustainability benchmark with relatively low tracking error to the underlying equity market. The parent index is a member of the MSCI ESG Leaders Index series. Constituent selection is based on data from MSCI ESG Research. The index applies a constant markdown ('synthetic dividend') of 3% on an annual basis, expressed as a percentage of performance.

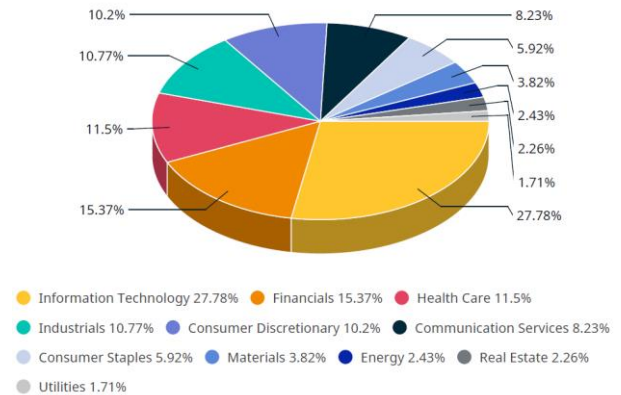

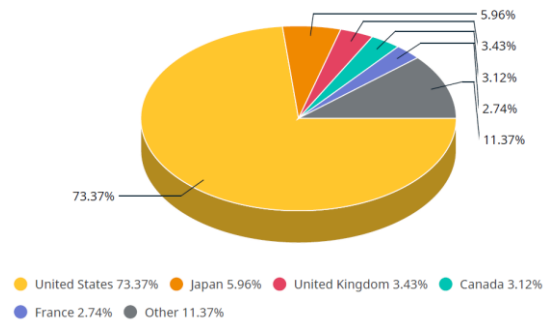
