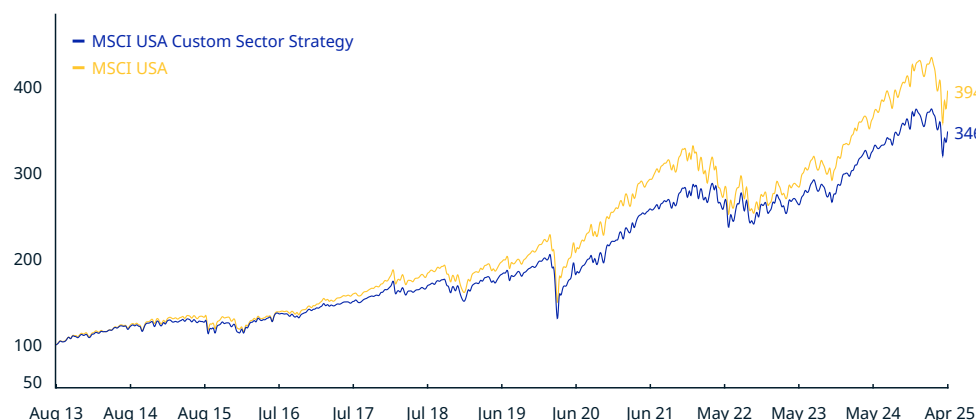


MSCI USA Custom Sector Strategy Index (USD)

The **MSCI USA Custom Sector Strategy Index** is based on MSCI USA Index, its parent index and is designed to measure the performance of the large and mid cap segments of the US market. At the inception of the Index and at each quarterly rebalancing - coinciding with the MSCI Quarterly Index Reviews effective at the open of the first business day of March, June, September and December - each sector as defined in the Global Industry Classification Standard (GICS®) is given an equal weight.

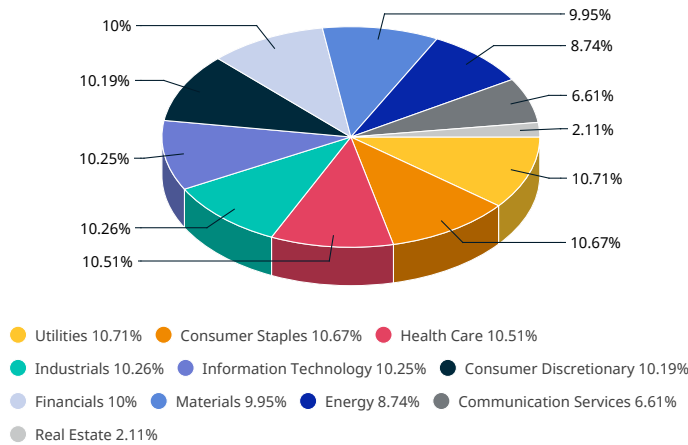
