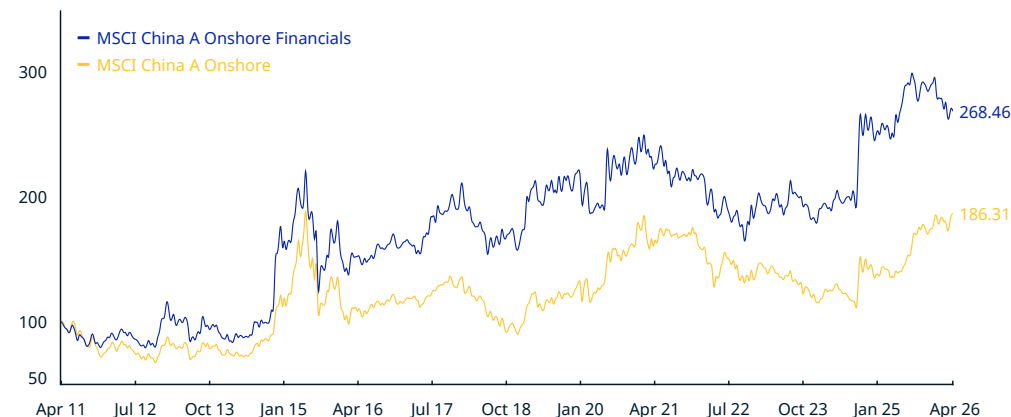


MSCI China A Onshore Financials Index (CNY)

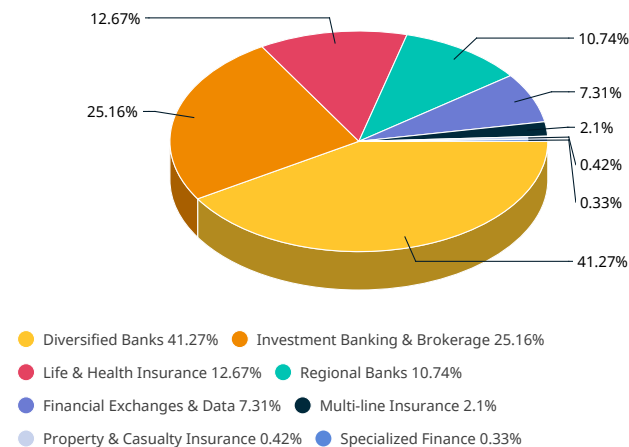
