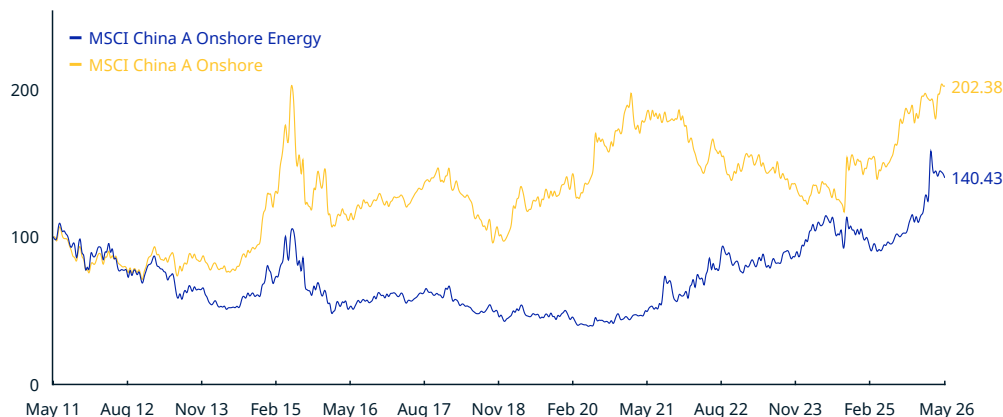


# MSCI China A Onshore Energy Index (CNY)

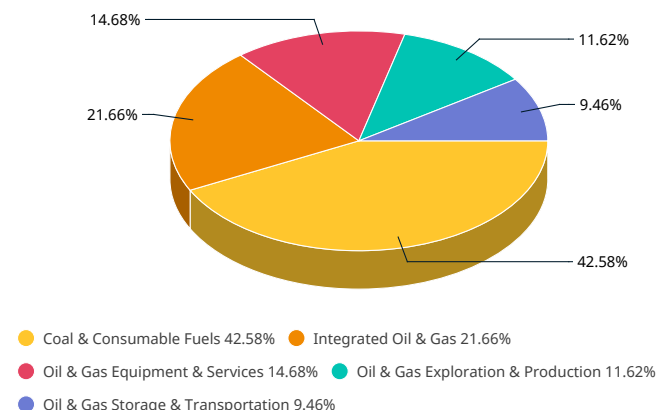
