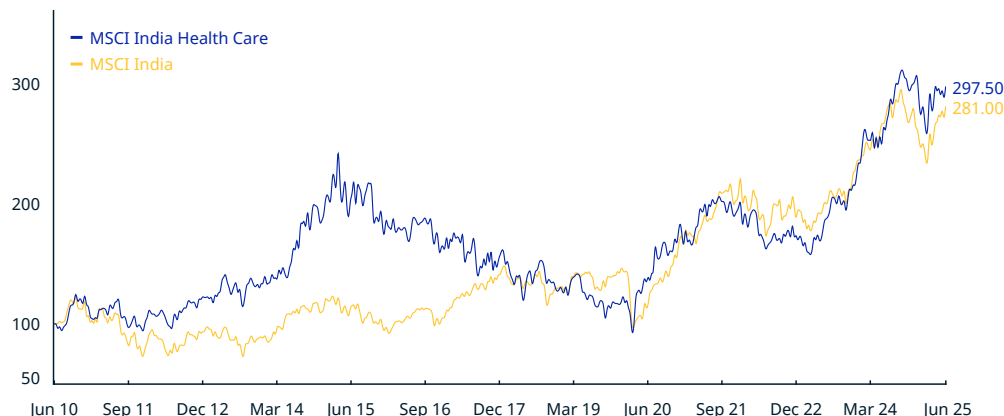


# MSCI India Health Care Index (USD)

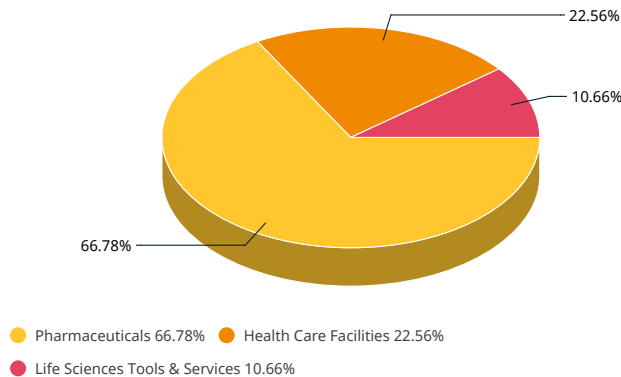
