
# MSCI Transatlantic Select Green 50 Decrement 3% Index (EUR)

The index also excludes companies that are involved in the production of controversial, nuclear or conventional weapons, as well as those that are involved in environmental and ESG controversies. The index aims to apply a constant markdown ('synthetic dividend') of 3% on the Net total return variant on an annual basis, expressed as a percentage of performance.




