

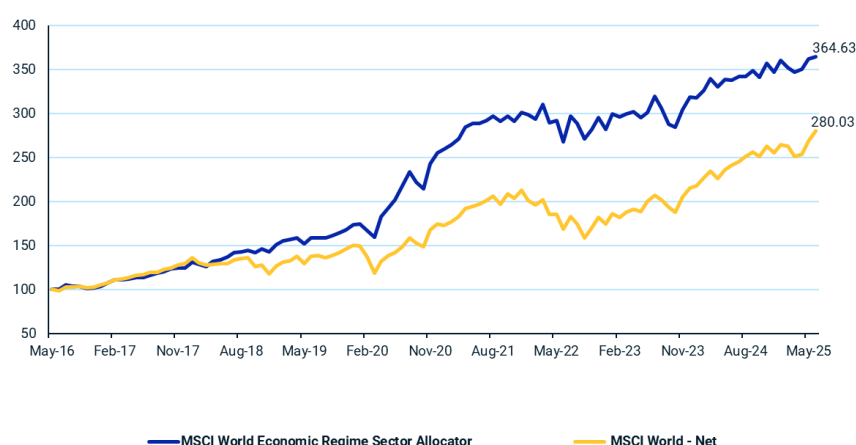
# MSCI World Economic Regime Sector Allocator Index
