

# MSCI Select ACWI Frontier Markets for Mexican Afores (MXN)

The **MSCI Select ACWI FM for MEXICAN AFORES** captures large and mid cap representation across 22 Developed Markets (DM), 13 Emerging Markets (EM) and 14 Frontier Markets (FM) countries approved by CONSAR as eligible countries for investments. With 2,321 constituents, the index covers approximately 85% of the investable equity opportunity set in these markets.

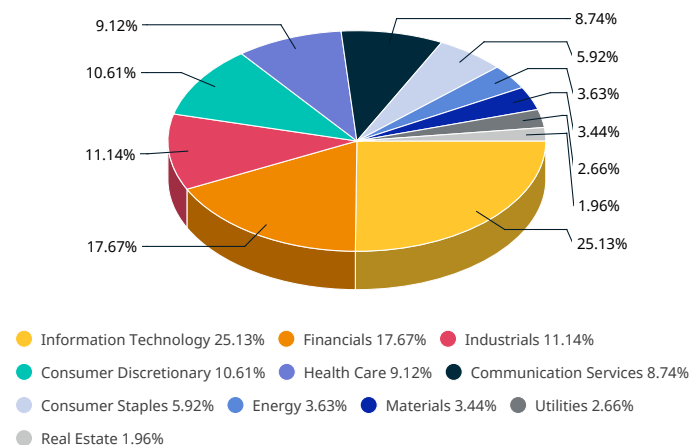

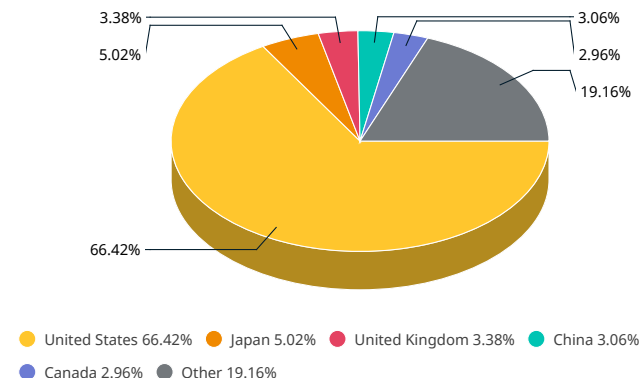
