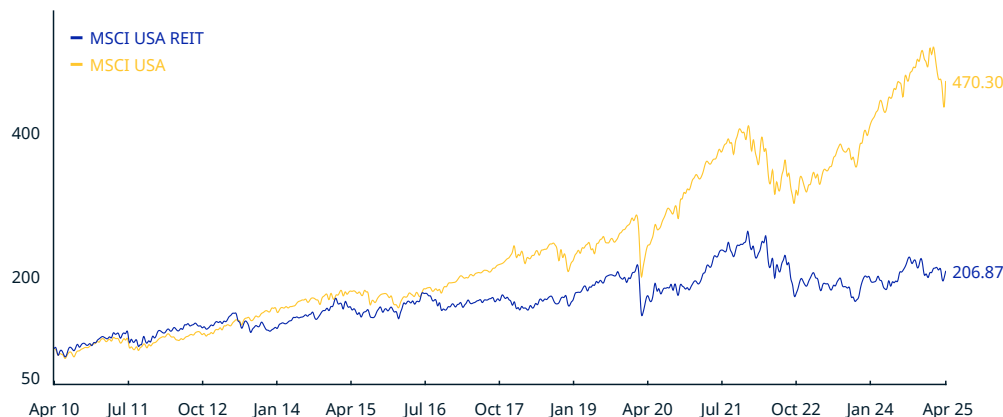


MSCI USA REITs Index (USD)

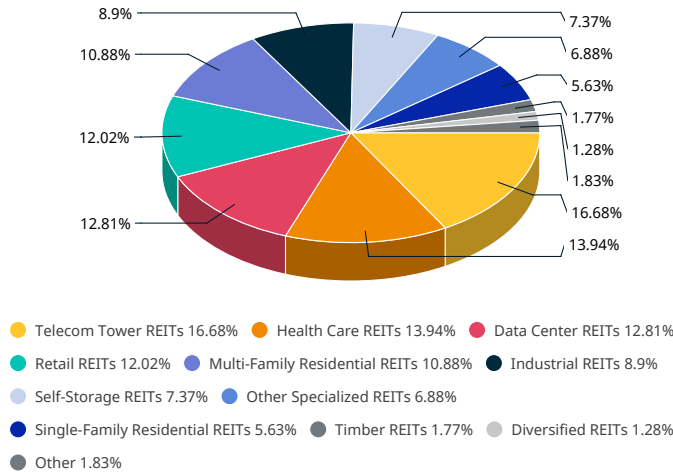
