

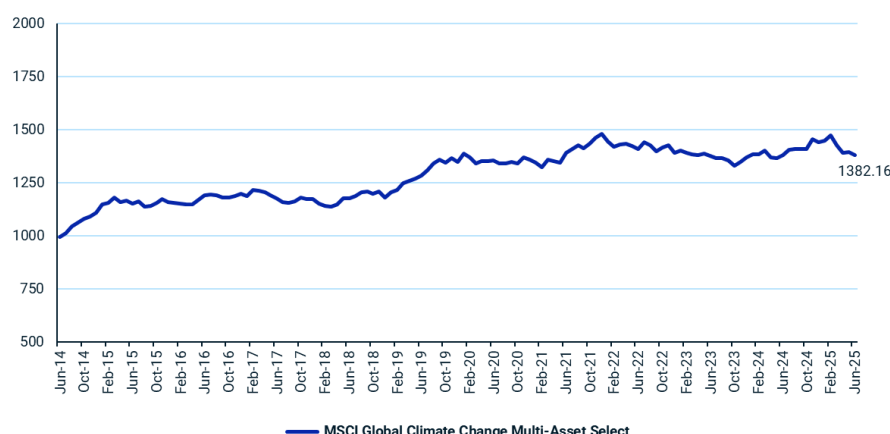
MSCI Global Climate Change Multi-Asset Select Index

The MSCI Global Climate Change Multi-Asset Select Index aims to represent the performance of the MSCI Global Climate Change Multi-Asset Select Combination Index while targeting an annualized volatility of 5%. The MSCI Global Climate Change Multi-Asset Select Combination Index is comprised of an equity and a fixed income index that both incorporate MSCI Climate Change Metrics¹ in their construction in order to assess a company's risk and opportunities related to the transition to a lower carbon economy. It consists of the following two components: a) the MSCI World Climate Change Select 200 Index that represents the performance of a strategy that seeks to minimize risk for a given set of constraints along with improvement in the Climate Change characteristics, and b) the MSCI USD IG Climate Change Corporate Bond Index which represents the performance of an investment strategy that re-weights securities based upon the opportunities and risks associated with the transition to a lower carbon economy.
