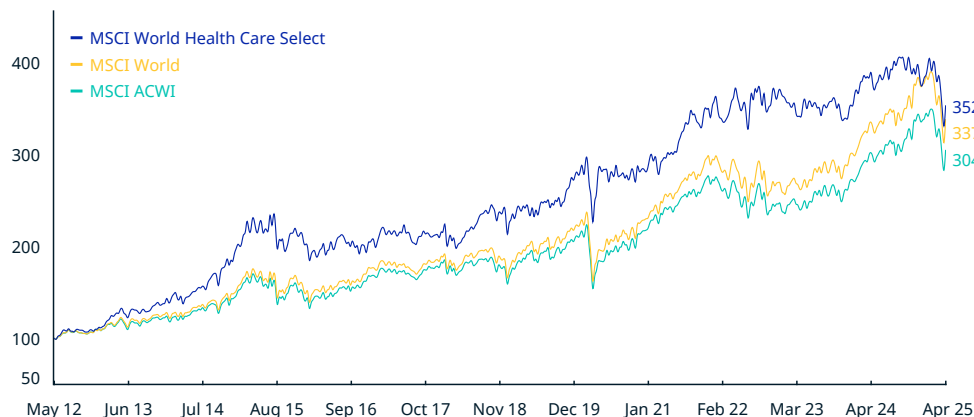


MSCI World Health Care Select Index (EUR)

The MSCI World Health Care Select Index is designed to capture select large and mid cap representation across 23 Developed Markets (DM) countries*. All securities in the index are classified in the Health Care sector as per the Global Industry Classification Standard (GICS®), selected based on their 3-Month Annualized Traded Value (ATV) and capped at a maximum weight of 5%.

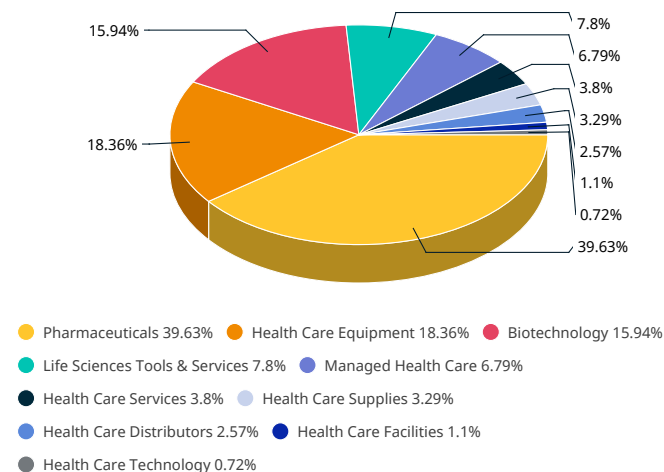

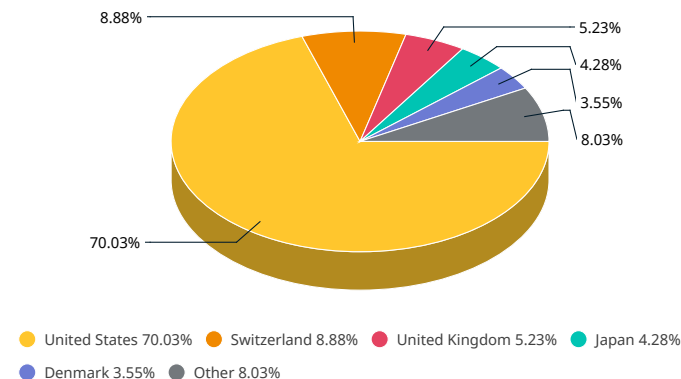
