The MSCI ACWI ex USA ex China ex Hong Kong Index captures large and mid cap representation across 21 of 23 Developed Markets (DM) countries (excluding the US & Hong Kong) and 23 of 24 Emerging Markets (EM) countries* (excluding China). With 1,388 constituents, the index covers approximately 85% of the global equity opportunity set outside the US, China & Hong Kong.

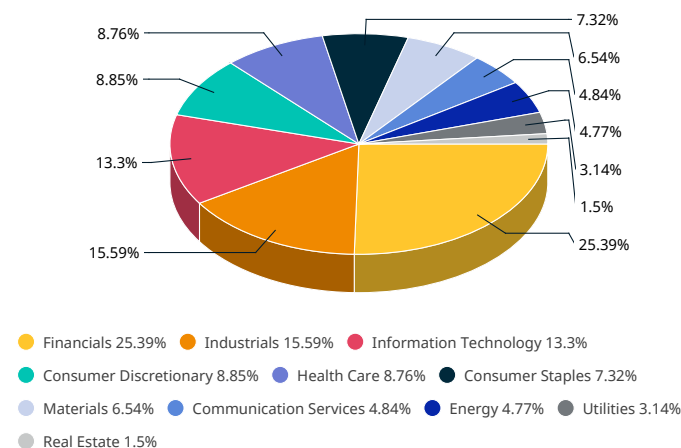

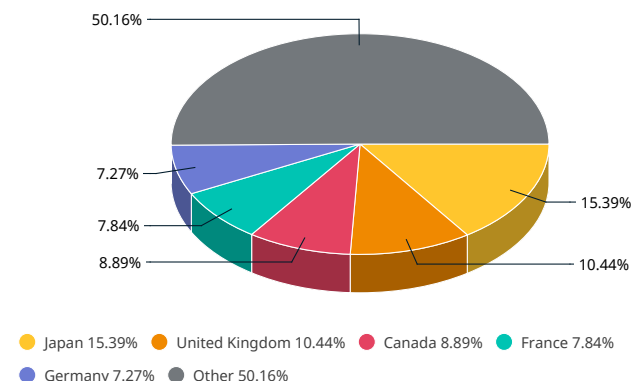
