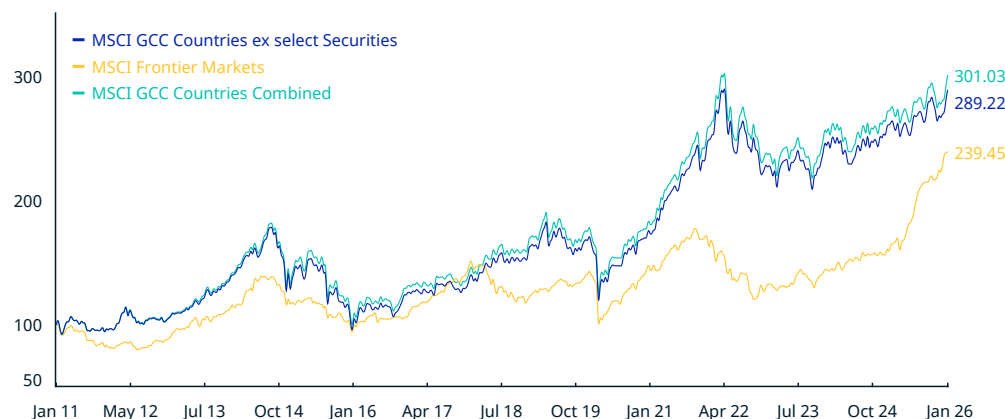


MSCI GCC Countries ex Select Securities Index (USD)

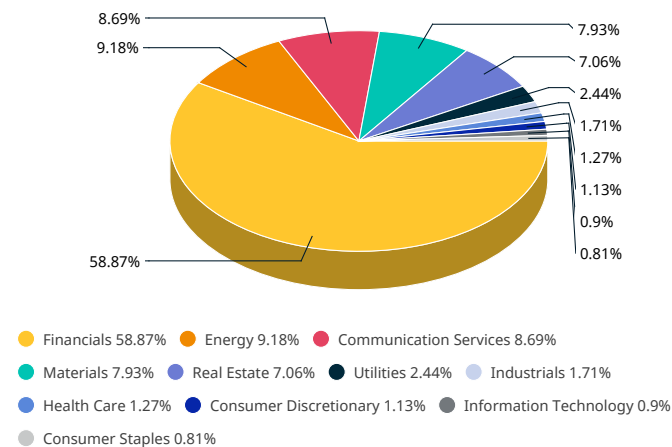

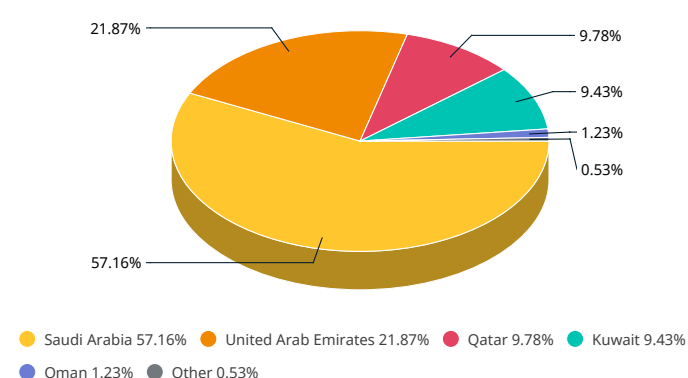
