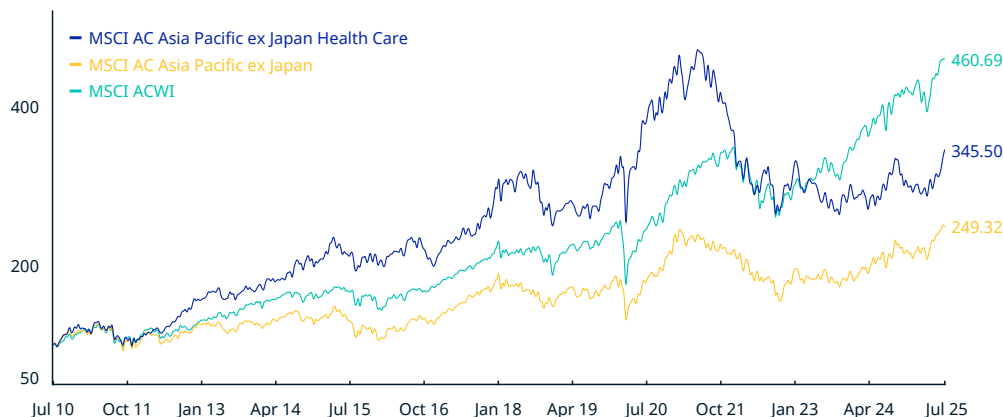


MSCI AC Asia Pacific ex Japan Health Care Index (USD)

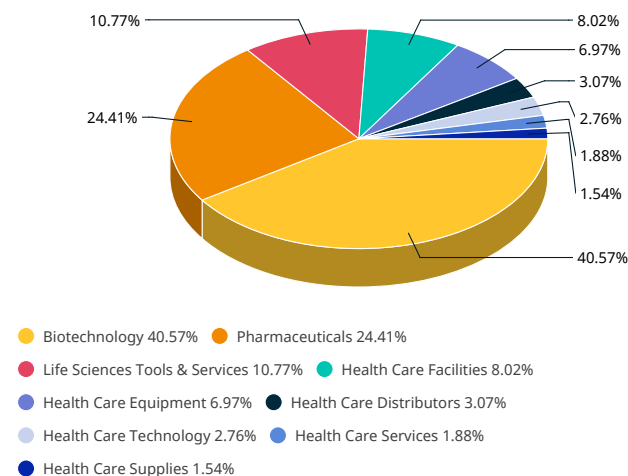

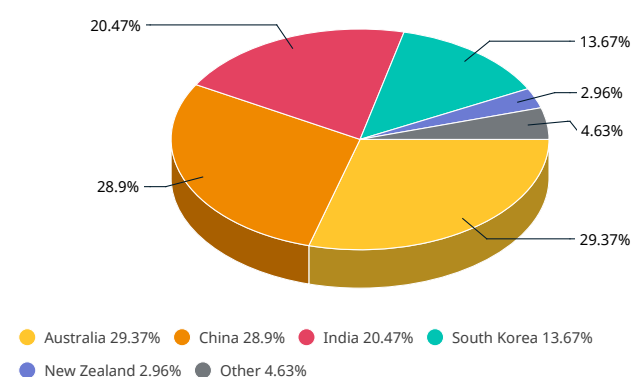
