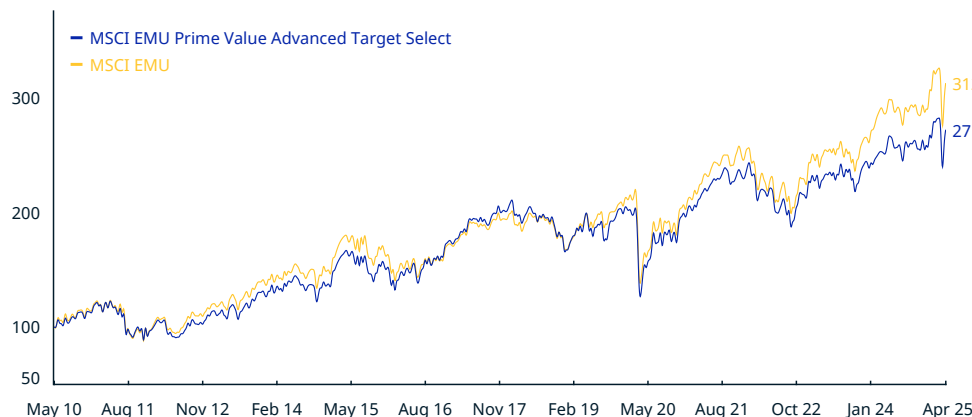


MSCI EMU Prime Value Advanced Target Select Index (EUR)

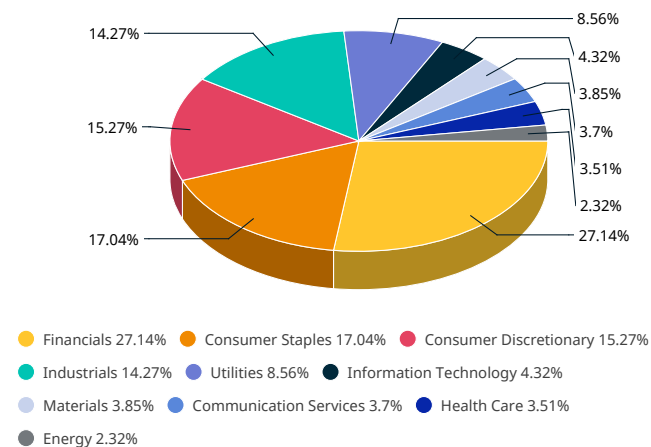
