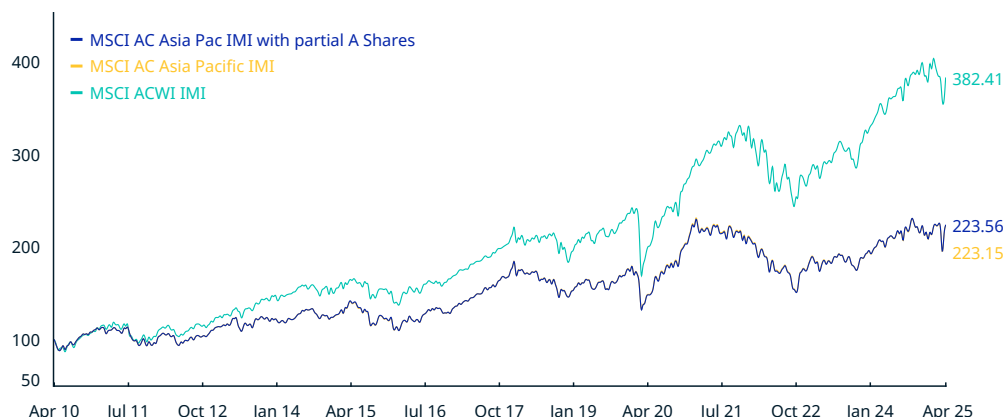


MSCI AC Asia Pacific IMI with partial A Shares Index (USD)

The MSCI AC Asia Pacific IMI with partial A Shares Index captures large, mid and small cap representation across 5 Developed Markets countries* and 8 Emerging Markets countries* in the Asia Pacific region. With 6,105 constituents, the index covers approximately 99% of the free float-adjusted market capitalization in each country. The index reflects the effect of a potential 5% partial inclusion of China A-shares into the MSCI Emerging Markets Index as outlined in the "Index Inclusion Roadmap for China A-Shares in the MSCI Emerging Markets Index" consultation proposal as part of MSCI's Annual Market Classification Review.

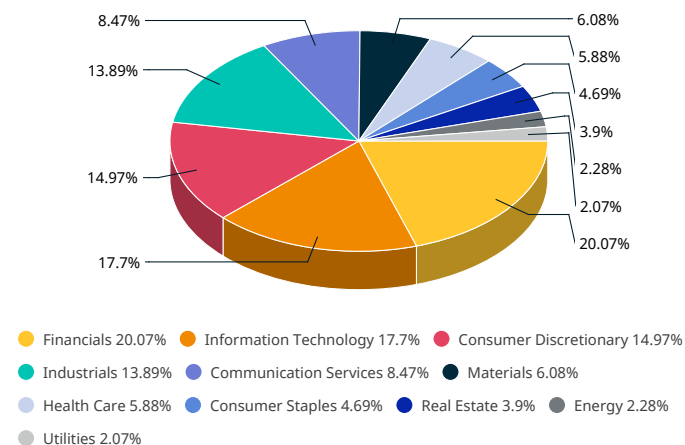

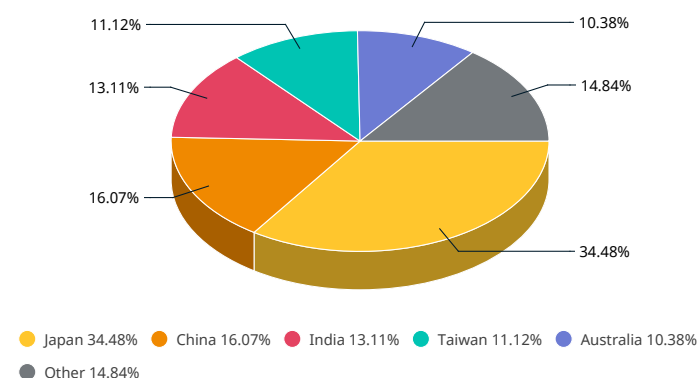
