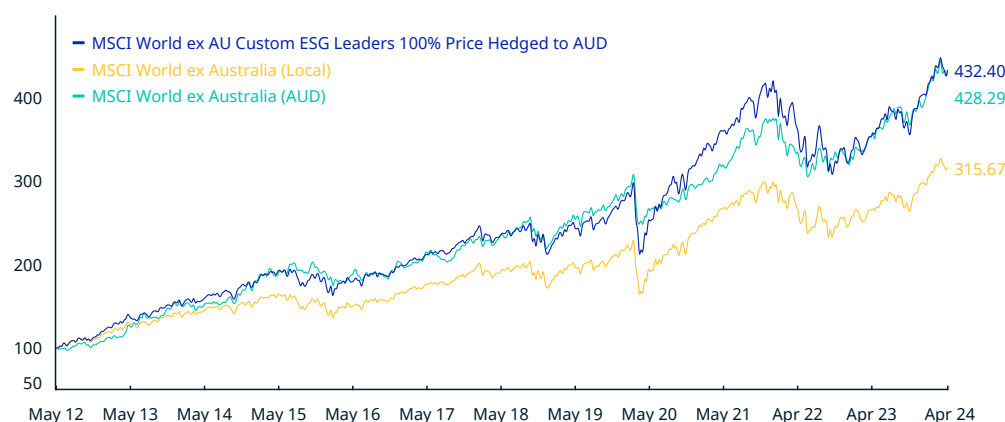


# MSCI World ex Australia Custom ESG Leaders 100% Price Hedged to AUD Index (AUD)

The MSCI World ex Australia Custom ESG Leaders 100% Price Hedged to AUD Index represents a close estimation of the performance that can be achieved by hedging the currency exposures of its parent index, the World ex Australia Index, to the AUD, the "home" currency for the hedged index. The index is 100% hedged to the AUD by selling each foreign currency forward at the one-month Forward rate. The index captures large and mid cap companies in 22 Developed Markets (DM) countries\*. The Index aims to represent the performance of companies that are consistent with specific values and climate change-based criteria. The Index is designed to represent the performance of companies that have high Environmental, Social and Governance (ESG) ratings relative to their sector peers.

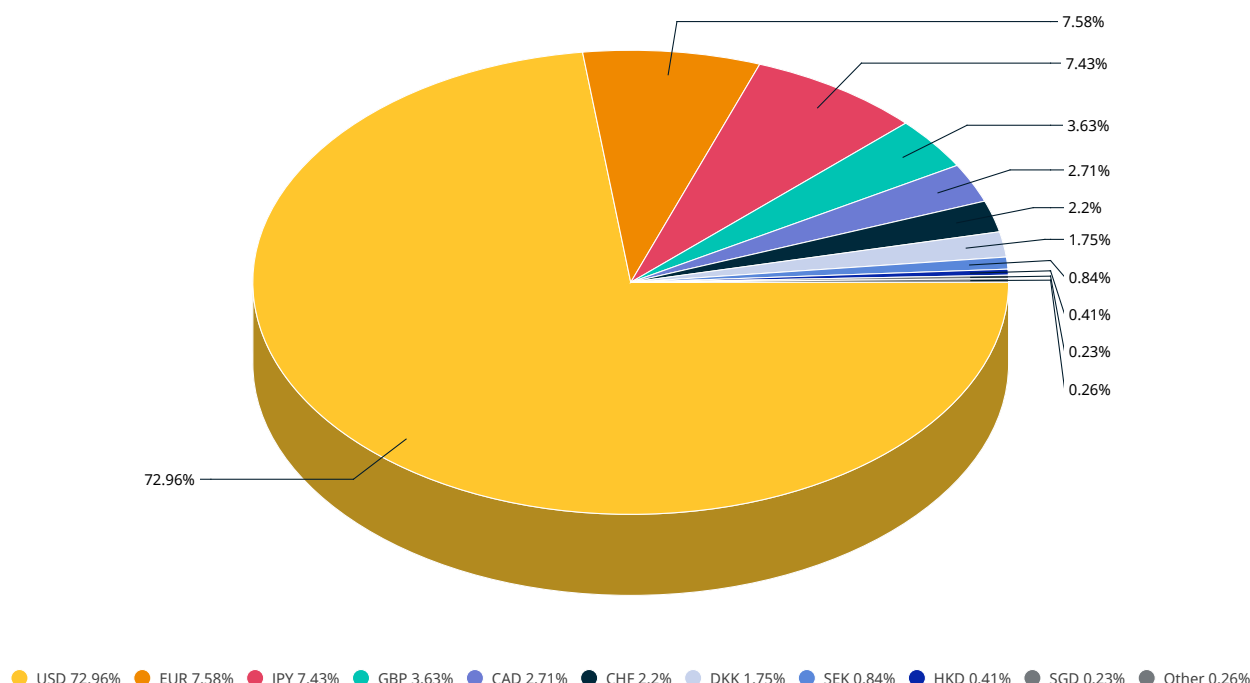
