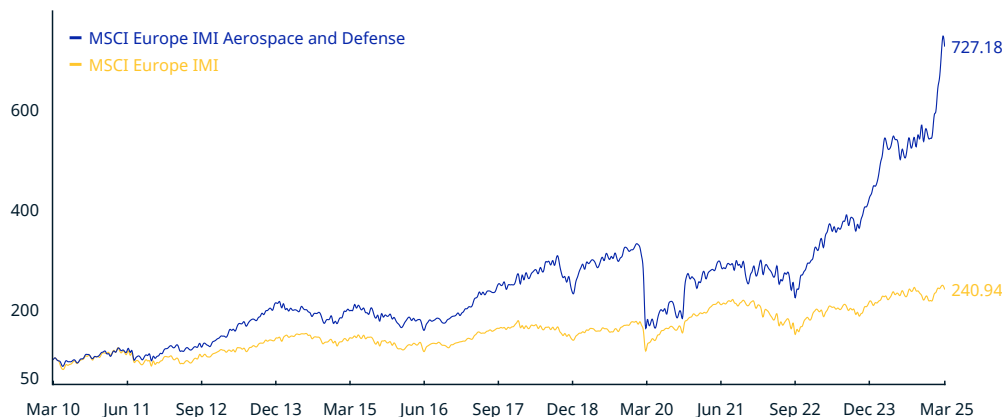


# MSCI Europe IMI Aerospace and Defense Index (USD)

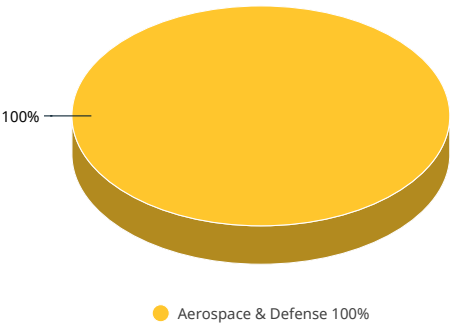

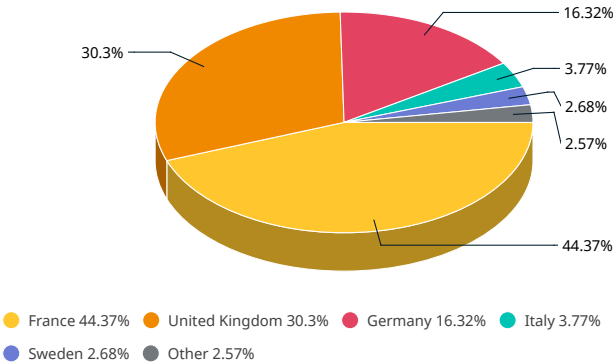
