The Index is designed for investors seeking a diversified Socially Responsible Investment (SRI) benchmark comprised of companies with strong sustainability profiles while avoiding companies incompatible with values screens. The index is a capped version that limits company concentration by constraining the maximum weight of a company to 5%.
