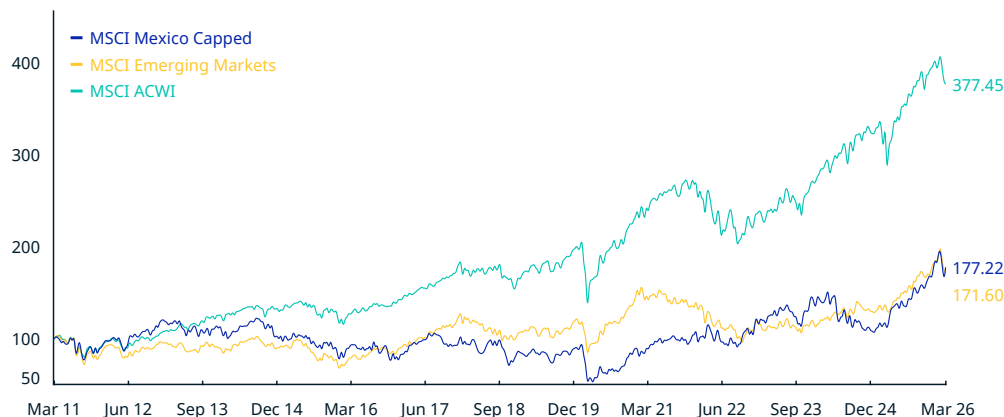


MSCI Mexico Capped Index (USD)

The **MSCI Mexico Capped Index** is designed to measure the performance of the large and mid cap segments of the Mexican market while capping the weight of the largest companies to help ensure index diversification. With 22 constituents, the index covers about 85% of the free float-adjusted market capitalization in the Mexican equity universe.

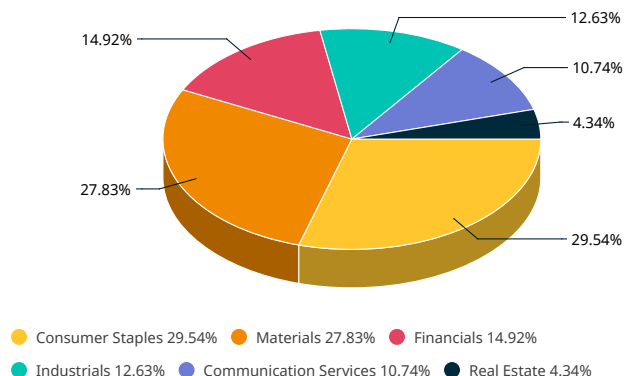
