

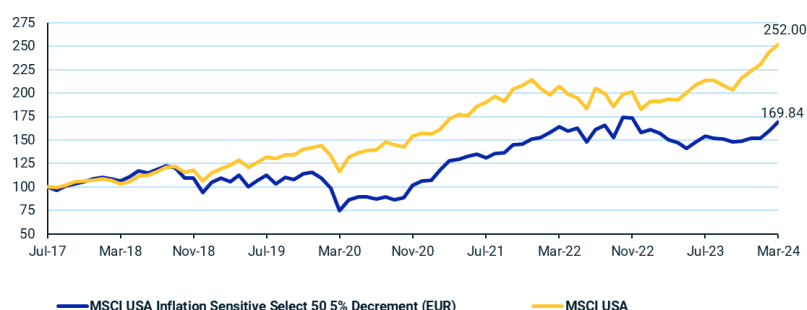
# MSCI USA Inflation Sensitive Select 50 5% Decrement EUR Index

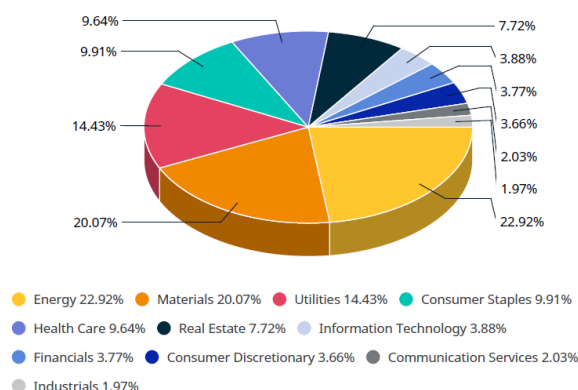
