The MSCI World ex Select Securities Index captures large and mid cap representation across 23 Developed Markets (DM) countries*. The index excludes a set of securities** from the MSCI World Index. The remaining index constituents are weighted according to their free float adjusted market capitalizations applicable to foreign investors. Each country's weight within the Index will fluctuate over time according to market movements.

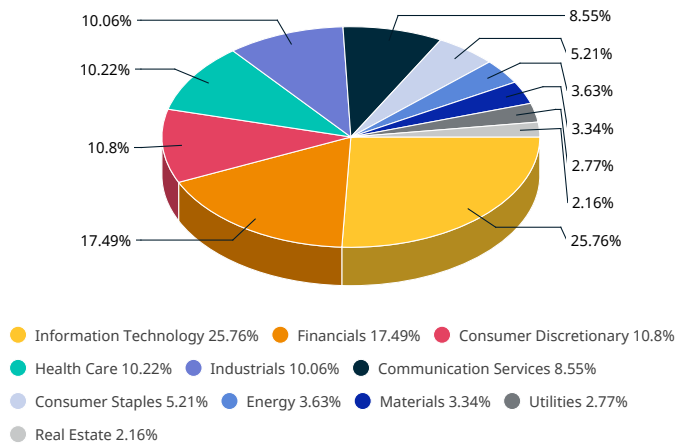

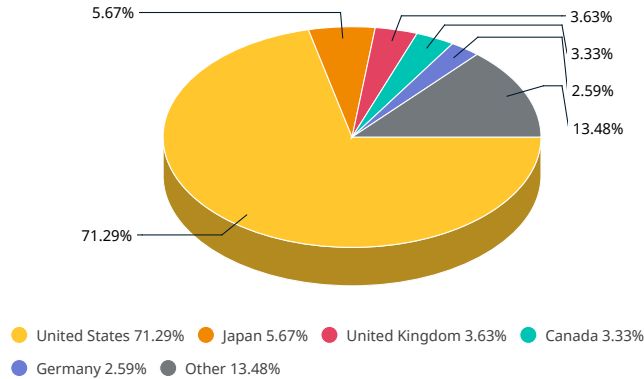
