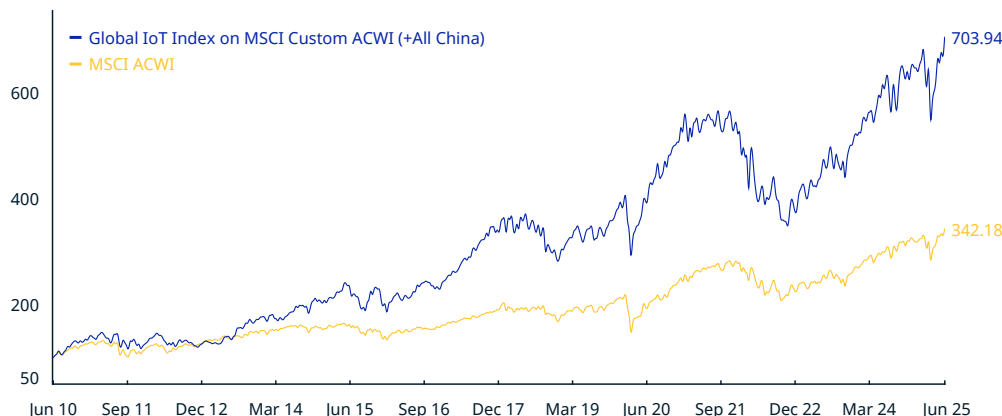


Global IoT Index on MSCI Custom ACWI (+All China) (USD)

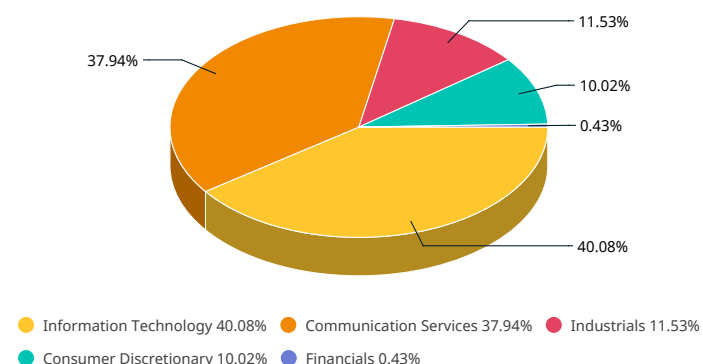

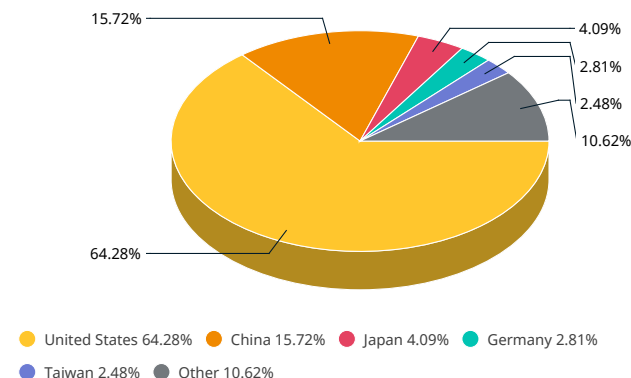
