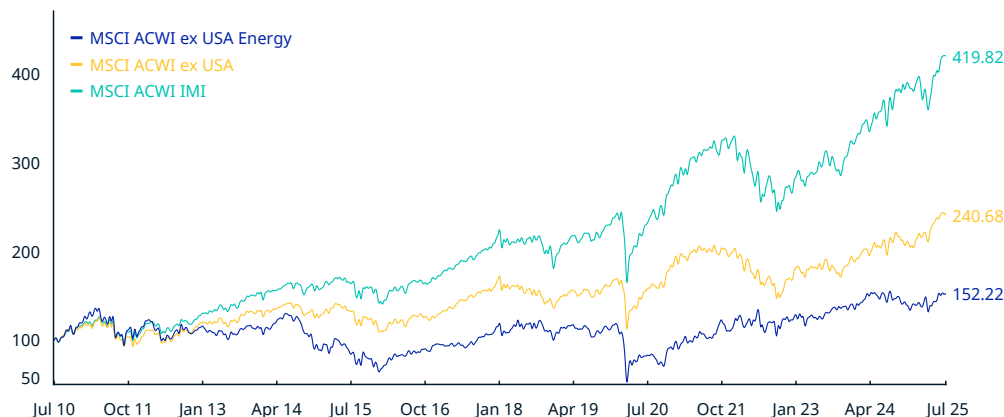


MSCI ACWI ex USA Energy Index (USD)

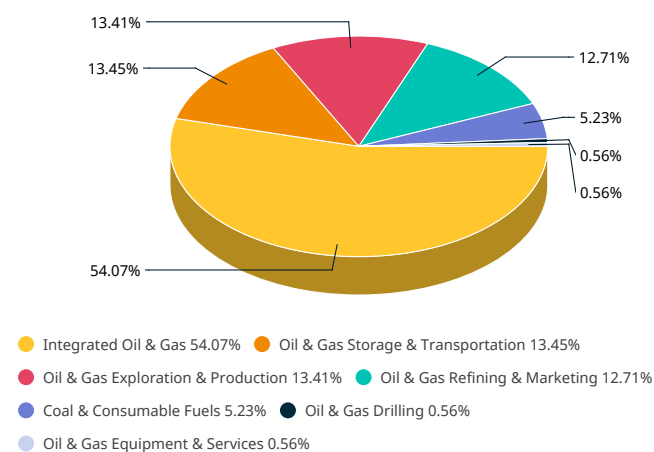

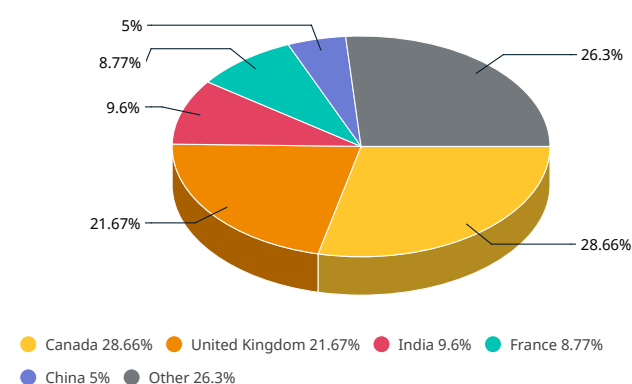
