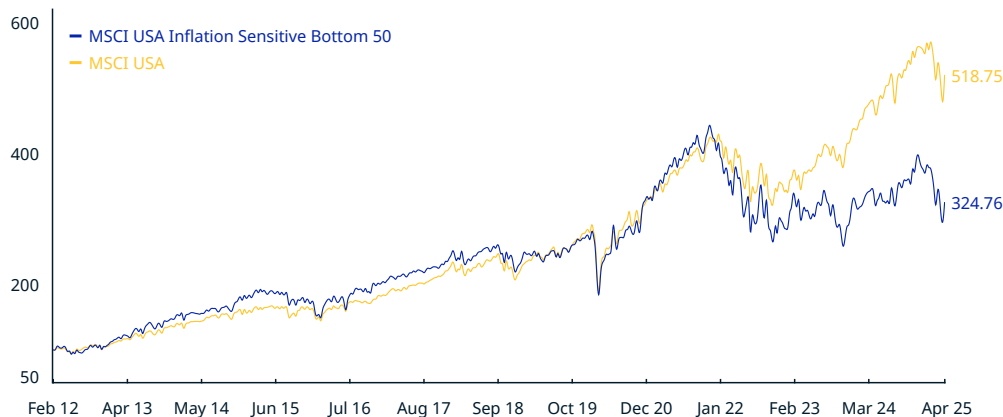


# MSCI USA Inflation Sensitive Bottom 50 Index (USD)

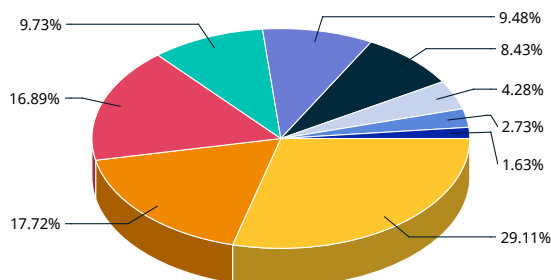
